

PRACTICUM PROGRAM AT UNIVERSITY OF IOWA

Not all graduate library schools offer practicum or internship programs, perhaps because such programs present difficult administrative problems. Teaching libraries, similar to teaching hospitals, do not exist, although they would be an asset to the current library science educational scene. At the University of Iowa, clinical experience under professional direction has provided a suitable substitute for a more highly structured internship program. The course is an elective, but about 75% of the students choose a practicum experience. Insofar as possible, the student is assigned to a library which matches his or her career objectives and has the opportunity to bring together knowledge and theories learned in library science courses and apply them in supervised library situations.

The practicum course seminar series includes weekly seminars and reading assignments and has been restructured to focus on non-bibliographic topics: personnel, management, supervision, interviewing, job seeking, advertising, and public relations. The student receives three semester hours of credit and must spend a total of 80 hours in the field. Many library practicum supervisors here have gone through the practicum experience and are especially attuned to the program's intent. Clinical experience provides the student with a) an understanding of the overall functions and services of the library department through consultation with the professional supervisor, b) a first-hand knowledge of professional library activities, and c) experience with clerical tasks to provide a basis for training and supervising personnel in these areas.



At the close of the practicum experience the supervising librarian completes an evaluation report on the student's progress, similar to the one used for practice teaching in the College of Education. At least two of the seminar meetings are devoted to student discussion of their practicum experience; usually these discussions are held in small groups, broken down by type of library (i.e., university, school or public). Currently, 25 students are carrying on practicum experiences in a variety of libraries - university, college, elementary, junior high and high school, community college, law, hospital and medical, and special libraries.

STATUS OF PLANNING:

STATE WHITE HOUSE CONFERENCE A C T I V I T I E S

NEVADA has forwarded its Letter of Intent to conduct a State Conference preceeding a White House Conference on Library and Information Services to the National Commission on Libraries and Information Science. Under the date of October 1977 the application for federal assistance in this matter is currently under A-95 review process and will go forward 7 November 1977. The tentative budget for the Conference assumes an NCLIS grant of \$13,750, an allocation by the Nevada State Advisory Council on Libraries of \$2,500, income from other sources of \$3,500, and in-kind support of \$9,250 (state fund source) for a total of \$29,000.

After consultation with Governor Mike O'Callgahan and consistent with his guidance, the official authorizing agent and state administrator is Joseph J. Anderson, State Librarian. The Executive Coordinator for the State Conference is Mr. Harold H. J. Erickson, Director of Libraries, University of Nevada at Las Vegas. The Chairman of the Citizens Advisory Committee for the event is the Honorable Grant Sawyer, former Governor of Nevada and an Attorney at Law practicing in the city of Las Vegas. While the Advisory Committee membership won't be completed until the end of November, it is anticipated that it will consist of twentyfour persons selected for their interest in libraries, variety of walks of life, and geographic representation of the State.

The Nevada State Conference is anticipated for late fall 1978 and will be of a duration of two days. It will be the business of the Advisory Committee when completed to determine the city and conference site which at this time may be at Las Vegas for reason of the larger attendance at less cost considering the problems we have in our State.

It is anticipated that a "three track structure" will be developed to focus issues of the content of the Conference. There will be a series of activities conducted by the Nevada State Advisory Council on Libraries, the Nevada Library Association, through its organizational structure, the Advisory Committee through its guidance and the State Library agency which together will develop the necessary information and clarify issues to be structured as the content of the Conference.

NEBRASKA

A White House Conference Committee has been established as a special committee of the Nebraska State Advisory Council on libraries. The committee has the responsibility to plan statewide activities prior to White House Conference. The activities are to serve as an update to the 1976 Nebraska Governor's Conference on Library Services. NLC's liaison with the White House Conference Committee is Marla Bouton

KANSAS

The Governor of Kansas has appointed a Task Force on Libraries and Information Service which may culminate in a governor's conference in the fall of 1978 or Spring of 1979. The Task Force's activities will provide input to the conference which will be planned and carried out by the Kansas Library Association and other library associations in Kansas. Detailed planning for the governor's conference is being delayed while waiting for the Task Force to receive its complete change. Charles Bolles is contact person for information on planning and development of Kansas activities.

SOUTH DAKOTA

After considerable discussion with the National Commission on Libraries and Information Science and their lack of acceptance of proposals made by the State Librarian for gathering input on the State Level for the White House Conference to be held in 1979, as well as their insistance that the state put up matching funds for a state level conference highly structured along their guidelines, the State Librarian, after a conference with the staff of Governor Kneip, had to notify the National Commission that the State of South Dakota would not participate. South Dakota will gather input through a series of hearings on a plan for statewide library development and will make that information available to the White House Conference if they are willing to accept it.

THE OUTSIDER AND THE KANSAS COMMUNITY COLLEGE LIBRARY

In recent years the act of refusing full library service to community college outsiders, i.e. members of the community at large who are neither enrolled in nor employed by the community college, has been consistently discouraged in the library literature. Both the GOAL AND OBJECTIVES OF THE AMERICAN LIBRARY ASSOCIATION (adopted January 24, 1975) and the U.S. National Commission on Libraries and Information Science's TOWARD A NATIONAL PROGRAM FOR LIBRARY AND IN-FORMATION SERVICES: GOALS FOR ACTION (1975) clearly support the concept of maximum feasible information access for all Americans. Though neither statement specifically advocates the circulation of library materials to outsiders, the NCLIS report does suggest that:

... the total library and information resource in the United States is a national resource which should be developed, strengthened, organized, and made available to the maximum degree possible in the public interest.

The practice of refusing full service to community college library outsiders does persist, but if public community colleges in Kansas may be judged as representative, it appears that the practice has come to an end.

In November, 1976, a survey of all 19 public community college libraries in Kansas indicated that:

- 1. 100% of those libraries permit outsiders to use library materials in the building.
- 94% routinely circulate library materials to outsiders (AV hardware and software are often excluded).
- Of those presently lending to outsiders, 55.5% require that outsiders be registered with the library prior to lending while the remaining 44.5% do not require such registration.
- Only 1 of the community college libraries presently lending requires a fee for registration.
- Over 61% of those lending to outsiders publicize this service. This publicity takes the form of word-of-mouth, the local newspaper, the student newspaper, radio or television, and letters.

These figures compare quite favorably with an earlier (1968) national ACRL survey of outside borrower practices in community college libraries in which it was determined that only 91% of the responding libraries permitted in-building use of the library collection by outsiders, while 70% permitted outsiders to borrow materials from the collection.

It would appear, then, that community college libraries (in Kansas, at least) have taken their responsibility to the non-student or faculty member very seriously. Not only do all of the public two-year institutions permit outsiders full access to their collections, well over half promote the service through the media, word-of-mouth, and letters.

¹Since November the one remaining community college library which did not circulate to outsiders has revised its policy to permit such circulation. At this writing then, 100% of the community colleges in Kansas circulate to outsiders.

Minutes of the Meeting of the Mountain Plains Library Association — Executive Board Civic Center, Rapid City, SD November 2, 1977

PRESENT

The meeting was called to order by the President, Vern West. Roll call was taken from a signed list. Those present were: Vern West, President; H. Robert Malinowsky, Vice President; Dorothy Middleton, Secretary; Peg Woods, Chairman, Trustees Section; Kelly Patterson, Chairman, Constitution and Bylaws; Glenn Sundvold, South Dakota Representative; Joseph Anderson, chairman, State Library Section; Barbara Mauseth, Chairman, Nominating Committee; Jean Diggins substituting for Kay Lundgren, Chairman, Children's and School Section; Charles Bolles, Kansas Representative and Chairman, Technical Services; Jim Dertien, Nebraska Representative; Vince Anderson, Past President; Donald Schmidt, Utah Representative; Dennis Page, North Dakota Representative; Carol Connor, Chairman, Public Library Section; Bob Carmack, Chairman, College and University Section; and Jerry Kaup, Chairman, Finance Committee.

MINUTES

COMMITTEE REPORTS AWARDS

Vern West reported that the Awards recipients had been announced in the Newsletter and the awards are on display in the lobby of the Civic Center.

SCHOLARSHIP

No report at this time.

NOMINATING

B. J. Mauseth reported the outcome of the election. Jim Dertien is the new Vice President/President-Elect and Shirley Flack is the new Secretary.

PUBLIC RELATIONS

No report at this time.

CONTINUING EDUCATION

Charles Bolles reported on the One-to-One Program. Three grants have been made, one is still pending, and one will not be awarded because the recipient cannot make the visit due to work commitments.

CONSTITUTION

Kelly Patterson presented the Bylaws revisions as they had been mailed to Board members. She also presented a letter from Joe Edelen of comments on proposed changes in the Bylaws. Vince Anderson moved and Bob Malinowsky seconded to untable discussion of the Bylaws. It passed. Vince Anderson moved and Charles Bolles seconded that the report of the Constitution and Bylaws Committee encompassing changes in the Manual of Procedure be accepted and that the Executive Secretary be directed to publish it in sufficient operational copies and be authorized to make any editorial changes that may be necessary. The motion passed.

FINANCE COMMITTEE

Vern West reported that Jerry Kaup had recommended an audit of the books. An audit was made and all is in order.

Vern commended Joe Edelen on his conscientious handling of the MPLA finances and strongly recommended to the new Board that they consider an appropriate token of appreciation.

Kelly Patterson commended Vern for his dedicated work in raising the financial position of MPLA.

1977 CONFERENCE

Carol Connor moved and Peg Woods seconded that the MPLA Board greatly thank Philip McCauley and his fine Local Arrangements Committee for their very fine work in setting up this Conference. It was heartily passed.

1978 CONFERENCE

B. J. Mauseth announced it will be at Tahoe, Nevada, October 12-15. Vern West announced there will be a train to Reno that will include a side trip to San Francisco. There is space for 300 and reservations are available. Arrangements chairpersons are: Yvonne Saddler, Conference Chairman; Dorothy Rice, Program Chairman; Grace Jamisson, Local Arrangements Chairman; and Robin Barker, Exhibits Chairman.

1979 CONFERENCE

Vern West reported that the Denver Conference has been moved from the Executive Tower Inn to the Fairmont and other hotels to accommodate all the attendees.

1980 CONFERENCE

Bob Malinowsky reported arrangements are progressing with the Pacific Northwest Library Association.

NEWSLETTER

Vern West reported that Elizabeth Runyon-Lancaster has resigned as editor and the new Board will appoint the new editor.

CONTINUING EDUCATION SCHOLARSHIP

Vern West reported that while the Board has approved changing the Scholarship from one for a non-professional entering the field to a continuing education one for a person already in the field, it might be appropriate for the general membership to have a formal voice in this change. Bob Malinowsky will ask for a vote approving this change at the membership meeting. Charles Bolles will give the new Board a copy of possible guidelines for the new scholarship. The Board discussed points of the guidelines, particularly money, and it was decided the amount of the scholarship was not fixed, but could vary with money available.

WHITE HOUSE CONFERENCE

Vern West reported that a poll of the states in MPLA showed: one state strongly in favor of a state conference; several states not planning on having one and several states were undecided. However, all states would like some kind of regional conference or input into the White House Conference. Joe Anderson spoke on the need for western state input into the national conference and on the possibility of the MPLA states joining with the other western states for a regional voice. Bob Carmack reported Joe Edelen's concern about MPLA's financial responsibility in a regional voice, but Vern stated the MPLA financial position secure enough to plan for some expenses. Vince Anderson moved and Carol Connor seconded that the Executive Board recommend to the new Board that serious consideration be given to gathering regional input toward the White House Conference. It passed.

NEW BUSINESS

Charles Bolles reported that the Western Council of State Libraries is replacing WICHE and is interested in continuing education. Charles moved and Vince Anderson seconded that MPLA invite communication with the Continuing Education Task Force of the Western Council of State Libraries. It passed.

NEXT MEETING

The next meeting will be held Saturday, November 5, with the new Board.

The meeting was adjourned.

Minutes of the Meeting of the Mountain Plains Library Association — General Meeting Civic Center, Rapid City, S.D. November 4, 1977, 3:30 p.m.

The meeting was called to order by the President, Vern West.

PRESIDENT'S STATEMENT

Vern stated that it has been a pleasure to serve for nearly two years. He reported that the Association has moved in that time from being about \$8,000 in debt to having a comfortable plus balance. He said our better financial position was due to good Conferences and good help from the membership. He pointed out that the Conferences are showing a new thrust toward continuing education while still being a good place to meet with other librarians and exchange ideas.

Vern announced the new officers for the coming year as: President, H. Robert Malinowsky; Vice President/President-elect, James Dertien; and Secretary, Shirley Flack. Vern turned the meeting over to Bob Malinowsky.

UNFINISHED BUSINESS

Bob Malinowsky requested the names of all new section officers and state representatives be given to Dorothy Middleton before the end of the Conference.

CONSTITUTION AND BYLAWS

Kelly Patterson presented the proposed changes in the Constitution and Bylaws as they had been mailed to the membership and approved by the Board. Kelly moved to ratify the changes; Carol Connor seconded; the motion carried. Bob Malinowsky commended Kelly for her good work on the Constitution.

CONTINUING EDUCATION SCHOLARSHIP

Charles Bolles presented the background for changing the scholarship from one for a person entering the library field to include support for persons in the field wishing to do advanced work. Charles moved to redefine the existing scholarship program to allow for learning experiences in addition to beginning master's programs. Joseph Anderson seconded and the motion carried. Charles answered questions concerning selection of recipients and pointed out that scholarships may now be given to persons in the field who are pursuing less than one year program studies. Scholarship recipients would have to be members of MPLA for at least two previous years. The new Continuing Education Committee will draw up guidelines for administering the scholarships.

NEW BUSINESS

Bob Malinowsky announced the old and new Boards would meet jointly Saturday, November 5, at 9:00 a.m.

Andy Gibbons resolved to thank by acclamation our past president, Vern West, for all his work for the Association. Passed.

Joseph Anderson announced the State Libraries Section is interested in state activities concerning the White House Conference. The State Library Section will be trying to develop a western states position on critical issues. They will try to coordinate western concerns in forming national policy. They are working to set up a program at Tahoe to develop policy. They will use the MPLA Newsletter to keep the states informed of developments.

Vern told of a planned librarians train to the 1978 Tahoe Conference. The possible cost will be \$89.00 for the 300 available spaces. Over 80 reservations have already been made.

Bob Malinowsky asked for volunteers to serve on the next year's committees.

Joseph Anderson announced the Conference Committee will try to get recertification credit for the 1978 Conference.

PRESIDENT'S STATEMENT

Bob Malinowsky said it will be a big job to follow Vern. He will continue many of Vern's programs and work to keep the Association vital.

It was moved, seconded, and passed to adjourn.

REPORT TO THE MPLA EXECUTIVE BOARD FROM STATE LIBRARY SECTION:

The Section met and conducted its business meeting covering all items on the enclosed agenda.

1. Planning information was exchanged between the states of Kansas, Nebraska, Utah, South Dakota and Nevada. States not heard from were Colorado, Wyoming and North Dakota. It was reported that South Dakota and Wyoming will not be conducting state conferences as such, but will carry on activities designed to achieve related results. Nebraska, having conducted a successful Governor's Conference last year, will update that activity as appropriate

ACTION: It was decided that an effective strategy for interstate communication be established for sharing planning information. Each state library will designate a contact person for this purpose. As information developes, it is to be forwarded to Robin Barker, Nevada State Library, who will disseminate to all concerned. It was also determined that a state section by-line on this should be submitted for regular publication in the MPLA Newsletter through the pre-WHC period.

Alice Ihrig, member of the National Advisory Committee to the WHC mentioned that the committee feels that flexibility in conducting this activity should be assured to the states and urged that state and regional written input be shared with the National Advisory Committee, Vince recommended that recommendations in writing be forwarded for the purpose of getting the library expertise of the West recognized in the development of library services policy.

2. After discussion there was concensus on the usefullness of a regional check of state conference results to determine whether there are critical issues upon which to take a western states position.

ACTION: It is decided that there is an action role to be developed by MPLA and coordination with PNLA, SWLA, California, and the Western Council of State Libraries is to be done.

It was reported that the Western Council is interested in this result and will consider working for this and financially assisting an appropriate activity.

- 3. WICHE WILCO WESTERN COUNCIL format and program re-direction was discussed by B. J. Mauseth, with focus on continuing education, staff development plans. State library staff persons from several states met under the sponsorship of the Western Council at Spokane in August to develop a working list of training needs and concerns of state library staffs and personnel (heads of function). They included networking, library development, legislative research and relations, documents, audio-visual, and institutions. Four fields of interest were then prioritized: library development, legislative reference and relations, institutions, and technology. Task forces are set to develop action in each of these areas for training state staffs. It was noted that a (one on one) staff exchange was decided; mention was made that the MPLA model was the inspiration.
- 4. This section will develop planning immediately for program content for the next MPLA conference based on items 1 and 2 of this agenda.
- 5. Enclosures relating this item were attached to the agenda, offered for information and awareness. The Chair recommends that MPLA address the Council of ALA on this matter on Support MPLA Advertisers!

grounds that local, national and state library development will be critically affected by state adoption of the principal of state reappropriation of federal funds. (We'll have to check on ALA procedure for this).

6. The procedural change (MPLA EXEC BD decision of 23 April 77) concerning section officers was read. Our nominating committee was appointed: Chairman: Charles Bolles, Kansas; Members: Morel Fry, Nebraska, Doug Hindmarsh, Utah. Joe Anderson, Nevada, will continue in the chair until procedure is carried out.

PS: Relative to agenda item 4, the section program planning committee for next conference is: Charles Bolles, Kansas; Morel Fry, Nebraska; and Mary Southwell, Utah.

CLENE/USOE RECOGNITION PROJECT NEARS COMPLETION

The final stage of gathering opinion for the CLENE/USOE Continuing Education Recognition Project has been completed this month. Over 80 library/media/information personnel throughout the United States were interviewed individually, either in person or by telephone, by the Project Staff, with assistance from Barbara Conroy, Educational Consultant from Tabernash, Colorado.

During the fall and winter of 1976-1977, 85 discussion groups, comprising nearly 900 librarians, met to consider how continuing education activities should be recognized and recorded. Comments from these groups were summarized in a draft that elicited further written responses.

The interview stage of the project was designed to contact people in those states where discussion groups had not been held. Interviewees were chosen through random selection. Ms. Conroy interviewed a cross-section of the three allied professions in the Boulder/Denver, Colorado area, while the Project Staff contacted a similar group in the Washington, D.C. area.

The rest of the interviews were conducted by telephone in the states that had not held discussion groups on the issue. Interviewees were chosen through random selection. A cluster group (that is, two or three individuals) was generally interviewed in libraries in order to obtain ideas from practitioners at various levels of employment, including professionals and non-professionals. Each was interviewed separately. Usually one professional in media and information centers across the nation was contacted so that these groups would have broader representation.

Broadly speaking, a recognition system serves to encourage, support and recognize the efforts of those who pursue a

career-oriented learning plan. It is based on the premise that a carefully designed continuing education program will enhance an individual's competency and that recognition will encourage involvement. This should, in turn, strengthen employee effectiveness and improve service to the community.


Heretofore, recognition has generally been available only as credits earned in traditional academic programs or, more recently, with Continuing Education Units (CEU's) for approved courses. There has been no formal way to acknowledge participation in such educational experiences as non-credit institutes and workshops, home study, and even teaching courses and writing books.

Opinions regarding the recognition of continuing education activities have been gathered from over 1,000 practitioners in all fifty states through these personal interviews, reports from the ninety discussion groups, and from written responses. Findings from the survey and recommendations will be published along with the Project's final report at the end of September 1977 when the Title II-B Higher Education Act grant expires. This section of the report will be available upon request from the CLENE office.

During the CLENE Assembly, held in Detroit on June 23 and 24, 1977, the four Action Groups expressed particular interest in development of a recognition program for library/media/information personnel. Each group agreed to continue the project through further discussion and coordination. These groups consist of the four types of constituent members of CLENE: state library agencies, library associations, library schools and libraries, and individual members.

An important component of the Project has been development of the prototype home-based study course for library/media/information personnel, Motivation: A Vital Force in the Organization. Its purpose is to demonstrate that isolation, either by geography or by job situation, need not be a barrier to involvement in continuing education.

SHELVING TEST RUN COOPERATIVELY

Eight libraries in the Central Colorado Library System performed a cooperative exercise recently by simultaneously comparing times on three routine maintenance tasks: (1) loading book trucks with 75 selected books; (2) sorting the books in rough shelf order; and (3) moving the trucks to the shelving area, shelving books and returning the trucks to the loading area. Three classes of books were used in running these three task tests: mixed adult fiction and non-fiction, adult fiction, and adult non-fiction. Each test for each class was run twenty times.

In the end there was only slight variation in times for the three classes of books, but the third task (moving the trucks and actually shelving the books) showed significant time variation, a useful finding for the directors of the libraries involved. Barbara Cox, Map Librarian at the Univ. of Utah Libraries, participated in the program and brought home topigraphical, political and street maps from all over the world, but especially from the Middle East and North Africa, Central Europe, Scandinavia and Australasia. 
