Libraries and the Literacy Challenge: The Frontier of the 90's North Dakota's State Capitol Building is known as the "Skyscraper of the Plains." Built during the Thirties after the original 1883 building burned, it was designed in a style which would be efficient in operation. The exterior shows a towering business building flanked by the legislative wing and the new judicial wing. The exterior of the Capitol is cloaked in white Indiana limestone. Memorial Hall, with its 40-foot high bronze pillars, Belgium black marble and Montana yellowstone travertine walls and marble floor is highlighted with bronze chandeliers which extend twelve feet from the ceiling. Both House and Senate chambers are open for visitor viewing, as well as the nineteen story office tower which presents a breathtaking view of the capital city.

North Dakota speaks with many voices at the **Heritage Center** which is located on the Capitol Grounds next to the State Library. This theme reflects the infinite variety of the state and its people, and permeates the exhibits, collections and programs within the Heritage Center. Spacious and attractive, this new 127,000 square foot facility houses the State Museum, Archives, and a historic research library. Phased exhibits representing the entirety of state history, from the geologic beginnings to the Statehood Centennial in 1989, are available.

Creative Puppetry in the Library and Classroom

Judy Nichols, a popular storyteller and puppeteer, will present a program on "Creative Puppetry" in two sessions on Thursday, September 24.

Ms. Nichols has been delighting audiences for over 15 years with her unbounded enthusiasm and repertoire of folk and literary tales. Her goal is to enrich total learning experiences through the use of puppetry and storytelling.

A philosophical discussion on why puppets are such a valuable tool in working with children sets the pace for her workshop followed by an overview of how puppetry has developed in America over the past several decades. Resources such as books and materials are suggested, and demonstrations are plentiful. Many clever ideas for using a "Buddy" puppet in the classroom or library are explored.



Judy Nichols

For storytelling, Ms. Nichols encourages interaction through story cups, stories on sticks, bodi-puppets, creative dramatics, and lap puppets, how to use an overhead projector as a puppetry tool, and how to incorporate puppetry into teaching all aspects of the curriculum.

Ms. Nichols has an M.L.S. from Emporia State University and has worked in libraries and schools in Indiana, Illinois, Kansas and Texas. She is the author of Storytelling for Two-Year-Olds (ALA, 1987). She is a representative for Nancy Renfro Studios in Austin, TX.

Fighting Sexism in the Stacks

Women's studies (sometimes dubbed "gender studies") is an emerging interdisciplinary field closely linked to the social and political movement for equality of the sexes. Academic librarians are challenged to support research and teaching in women's studies.

Susan Searing, Women's Studies Librarian for the University of Wisconsin System, explores issues in collection development, cataloging, and public services that arise when the library responds to user demands for materials for and about women. She surveys the national scene, reporting on developments in publishing and information

Pre-Conference Grant to Nevada

MPLA's Continuing Education Committee has awarded a grant to the Nevada Library Association for a preconference to be held on October 7, 1987, on "Today's Woman Supervisor."

The committee also revised the dates for submitting applications, with May 1 the deadline for Fall conference grant applications and January 1 for Spring conference applications. They have also indicated that states may not receive pre-conference grants for more than two consecutive years.

Children's & School Section Develops Files

MPLA's Children's and School Section is developing two special files. One will be a file of past programs developed by the section. The other will be a file of School Media Center Guidelines from the different school districts in the MPLA area. Previous and recent inquiries for this type of information motivated the creation of these files.

BCR's First Group Access Project

The Group Access Capability (GAC) was designed by OCLC several years ago to increase resource sharing within cooperative Interlibrary Loan groups through use of OCLC's ILL subsystem. Libraries agree to form a group comprised of non-OCLC members, or selective users, and at least one OCLC library. The selective users are able to search the entire bibliographic database. The records contain all of the information needed to create ILL requests. An OCLC library can agree to serve as a referral center for the selective users. Therefore, if an item does not have the location of anyone in the group, the referral center initiates another ILL transaction and sends the request outside of the group. In this manner the resource needs of smaller libraries can be met while increasing the availability of materials to patrons.

A group of medical libraries in Colorado had been looking into the possibility of forming a GAC. After several meetings an agreement was reached whereby over 20 libraries, including several non-medical libraries, have organized the first GAC in the BCR region. This is only the second primarily medical GAC in the country. Denison Library at the University of Colorado Health Sciences Center has agreed to serve as the referral center, as well as the administrative body. (Action for Libraries, May 1987)

The Egyptian Connection

The Bibliographical Center for Research recently provided the first BiblioFile unit to be sold in Egypt. This was done through the auspices of Hart Phinney, Library Director at the Colorado School of Mines. Mr. Phinney will be doing consulting work for the Egyptian Geological Survey & Mining Authority. BiblioFile was selected as the tool to use to handle their cataloging needs. BiblioFile is an inexpensive CD-ROM based cataloging system developed by The Library Corporation. (Action for Libraries, April 1987)



Around the Region Arizona

Arizona Automation

The second generation of library computer systems in the Mesa Public Library will be DOBIS. It is being loaded at this time. The library plans to have it up in September. The Phoenix Public Library has begun bringing up CLSI at each of its branches on staggered dates. CLSI replaces the ULYSIS system. The Maricopa County Library District and the Maricopa Community College District are both bringing up Atlas's DRA system this summer to replace the Dataphase system. Since all of these libraries are in one single county, the Maricopa County Library Council has brought the Irving system from Colorado for a demonstration to see if it might be viable for support of Maricopa County's Reciprocal Borrowing Project. (MPLA State Representative report)

New Buildings

The Flagstaff Public Library will dedicate its new building in early May. The 60,000 square foot facility will give Flagstaff a needed new spaciousness for its library services. The Scottsdale Public Library will open its Mustang Branch (30,000 square feet) in the northern part of the city in early June. Opening at almost the same time will be Mesa's new Dobson Ranch Branch Library, a 15,000 square foot structure in the southeastern part of Mesa. The new Glendale Public Library main facility will open towards the end of summer in a 60,000 square foot structure.

Bismarck - The Beginning ...

Bismarck's name and location were determined by the Northern Pacific Railway in its program of constructing the first transcontinental railroad traversing the northern half of the United States. When its rail line reached the east bank of the Missouri River in Dakota Territory in 1873, it established a city and named it Bismarck in honor of Germany's "Iron Chancellor" as an inducement to have German capital invested in the transcontinental construction program. It was the western terminus of the railroad until the line was completed from the West Coast and a bridge was built across the Missouri in 1883.

With the arrival of the railroad, Bismarck became the center of trade for a vast area of western Dakota and eastern Montana Territory. It also became a major port on the northern Missouri River. The city of Mandan across the river was founded as a railway center and derived its name from early Indian tribes.

The **former North Dakota Governor's Mansion** located on Fourth St. was built in 1884 and housed the state's chief executives from 1893 until 1960 when a new residence was completed on the Capitol grounds. The mansion is mid-Victorian with bay windows, dormers, porches and balconies. The mansion has been "restored" and is maintained and shown by the State Historical Society.

Fort Lincoln State Park, located just south of Mandan at the confluence of the Heart and Missouri rivers, is North Dakota's most popular state park. Lewis and Clark landed here during their expedition on the Missouri River. Four Mandan earthlodges have been reconstructed at the site. The park location was also home to Fort McKeen, an infantry post, and the calvary post, Fort Lincoln. Blockhouses at Fort McKeen have been reconstructed and offer a panoramic view of the Missouri Valley. Fort Lincoln was the headquarters of Lt. Colonel George Custer and the Seventh Calvary and the point from which he left on the ill-fated campaign against the Sioux at the Little Big Horn. Reconstruction of Custer's home is currently underway. The original building sites of both forts are marked and the park contains a museum and interpretive center.

University of Mary and Annunciation Priory, located six miles south of Bismarck on the Missouri River bluffs, were designed by world-renowned architect Marcel Bruer. The setting is spectacular; the clean and striking design conveys the Benedictine ideas of permanence and stability.

Bismarck State College is located in northwest Bismarck and consists of 95 acres overlooking the beautiful Missouri River. It is the fifth largest post-secondary institution in the state.



Bismarck-Mandan Today ...

The spirit of the Old West lives on in the twin cities of Bismarck-Mandan (population 75,000). The area has become a commercial and transportation hub. Bismarck has become a thriving medical center and its facilities are utilized on a region-wide basis. In recent years, energy has played an important role in the growth of both cities. Projects in the planning stage include a new 60,000 square foot main library for the Tucson Public Library, a major underground addition to the Hayden Library at Arizona State University, a library for the new Arizona State University - West campus in Glendale, a tripling in size of the Phoenix Public Library's Cholla branch, and a replacement of the Tempe Public Library facility with a 110,000 square foot new structure. The Scottsdale Public Library is currently in the first phase of expanding its main library. By the time they are finished, the Scottsdale library will have approximately 60,000 square feet of service space available in the Civic Center complex. Chandler will move its library into a 30,000 sq. ft. office structure while its old library is replaced by a 60,000 sq. ft. new one. (MPLA State Representative report)

Debit/Credit Card System

The Main and Science-Engineering Libraries of the University of Arizona Library is installing debit/credit card systems on its photocopiers. The new cards will offer copies at six cents each to card holders, while coin and overthe-counter work will continue at ten cents.

The debit cards can be purchased in denominations of \$5, \$10 and \$20. The copier will tell the user how much is left at the beginning and end of each session. (AzU Library Newsletter, April 27, 1987)

New Reciprocal Borrowing Program

University of Arizona faculty will now be able to obtain borrowing privileges at other research libraries as part of a new Reciprocal Borrowing Program being coordinated by OCLC's Research Libraries Advisory Committee (RLAC). Fifty-seven libraries in RLAC have agreed on basic procedures which should make it easier for scholars to verify their institutional affiliation on research trips and more easily gain library privileges at participating universities.

Before departing their home campuses, scholars will need to obtain an OCLC card identifying their affiliation with an institution participating in the Reciprocal Borrowing Program. (AzU Library Newsletter, May 11, 1987) 20

SOLAR Coding Phase Completed

The initial coding phase of the Serials Online in Arizona (SOLAR) has been completed. A total of 46,204 serial tiles (A-Z) was gleaned from the U. of A. Serials List and individually coded for input. The majority of these coded titles was mailed to staff at SOLAR headquarters at the Arizona State University for input into the OCLC-based union list. The list displays the combined holdings for 16 participating libraries in OCLC. Access to holdings information is available online through OCLC or offline in microfiche format. (Research Libraries in OCLC)

Colorado

The Great American Library Chase

The Great American Library Chase is off and wheeling again! The Denver Public Library's annual fun and fundraiser event has expanded. The "Grand Tour," a bicycle trip between branch libraries along supervised, designated bikeways, is open to anyone who can pedal a bike and wishes to participate.

This year, a second event has been added, the "Denver Little 500" bike race at 1:00 in the afternoon. The exciting competition, modeled after the race featured in the film **Breaking Away**, pits corporate-sponsored, fourperson relay teams against each other in a grueling, 30-mile lap race. Spectators can see every thrill-packed moment from the bleachers.

The Great American Library Chase will be held Sunday, July 19, at Denver's South High School. Participants will be collecting pledges in advance for their trips.

"Grand Tour" bicyclists will choose from a 12- or a 24-mile loop course, beginning and ending at South High, in the morning. They will collect pledges from friends and neighbors. These contributions will directly benefit the Denver Public Library branch library or department that the rider chooses. United Airlines is offering two free airline tickets to anywhere in the United States for the person who raises the most money in donations on the "Grand Tour." (News release)

Technology Award to Westminster

The Westminster Public Library's bookmobile with a radio data system linking it to the library's central computer recently won the "Computer Technology and Telecommunications" category of the 1986 Public Technology, Inc. (PTI), Achievement Awards. PTI is the nonprofit research and development branch of the International City Management Association and the National League of Cities.

Katherine Phenix, who developed the idea, observed other communication activity such as paging, cellular telephones and mobile terminals in police cars. After attending a CCLS seminar on telecommunications and data storage techniques, she began the search for vendors who could provide the needed telecommunications equipment. Hardware includes one host radiomodem, one terminal radiomodem, one CRT, two antennae, RS-232 cable, and coaxial cable. The radio modem equipment is designed to link any type of CPU with up to 255 terminals.

Public Technology, Inc. has included the Westminster project along with winners of 12 other categories of local government awards in their publication **Solutions for Technology-Sharing Networks**.

First to Use Books in Print Plus

The Pueblo Library District's Technical Services Department received recognition from Baker & Taylor as having been the first library in the nation to have successfully transmitted an order to them utilizing Books in Print Plus (Bowker) in conjunction with Batasystems. The system enables the staff to perform pre-order searching and collection development activities more efficiently, plus saving clerical time with electronic ordering with Baker & Taylor. (System Beat, May 1987)

Get Out of Jail Free

Lamar Public Library presents a "Get Out of Jail Free" card to new borrowers, Friends, and for other special reasons. If a patron has a fine, he or she can give the card to the Lamar staff and the fine will be forgiven. So far, it has been well received. (System Beat, May 1987)

Kansas

Nuclear Waste Information

Kansas residents can no longer be accused of flaccid acceptance of whatever comes their way. With the Kansas Department of Health and Environment's establishment of the Phillipsburg City Library and the Port Library in Beloit as repositories for information regarding the siting of a low level radioactive waste facility for a five-state area, few were unaware that Kansas has 75 percent of the area deemed suitable for a dump site for a five-state regional compact.

The Central Kansas Library System has prepared a bibliography on nuclear waste. The bibliography has been sent to each system member librarian, and the books and photocopies of journal articles are available through the CKLS ILL Department. (CKLS Post, August 1987)

Farmers Union Supports Libraries

The 1987 policy of the Kansas Farmers Union includes a statement of support for Kansas library services. The statement was adopted by the delegates at the Annual Convention, and reads as

follows:

We urge Kansas counties to maintain their support of regional library systems to help local libraries provide needed materials and services for county and state residents and to offer direct services to rural patrons.

We support continued funding of the interlibrary loan development plan which will increase the number of books available state-wide for citizen use.

We urge Kansas residents to explore and use the services and materials of their local libraries and the resources of libraries through the state. (CKLS Post, May 1987)

Montana

Trustee Association Honor

ALA's presitigious Trustee Association Honor Award has been presented to the Havre Medical Clinic doctors who are recognized for their donation of the old Havre Clinic Building to be used as a new library facility. This major benefaction to the Havre-Hill County Library was recognized nationally by the ALA organization and celebrated at a reception on April 5.

This was the largest single gift to any library in the United States during the past year. (Montana State Library News, March/April 1987)

Logging and Ballet Company?

Yes, this Spring the Montana Library Association's annual conference featured as entertainment the Montana Logging and Ballet Company. The conference even saw an auction involving the sale of Sara Parker's pecan cheesecake and Phelps Shepherd's Adirondack chair with a carved library logo. The auction raised \$1,300 for the legislative committee and travel grants.

MPLA was represented by its executive secretary, Joe Edelen. It was reported that Mr. Edelen contributed "astute" comments throughout the conference. Those South Dakotans will try anything.

Nebraska

Moroccan Libraries

At an April 15 Special Libraries Association, Omaha Area Chapter meeting at the C.Y. Thompson Agriculture Library at the University of Nebraska-Lincoln, Richard Jizba recounted his experiences as consultant to the Mid-American International Agricultural Consortium on the Moroccan Dryland Research Center Project. Research there is designed to make better use of the limited water and soil resources of the region. The Dryland Research Center has a library staffed by an American with a library degree, but Richard's practical experience was needed several weeks each year.

Richard described a few of the many problems involved in starting a library in Morocco. Libraries are rare in Morocco. It is not possible to get some literature into the country. The telecommunications system is so bad that online searching is impossible. Interlibrary loan is costly, and there's not a lot of money available for library development. However, the government has jumped headlong into technology, and the library has a sophisticated computer, if not an extensive collection of journals. (River City Reporter, Spring 1987)

Octanet Phased Out

Octanet, the automated interlibrary loan system developed and used by the Midcontinent Regional Medical Library Program, is being phased out this spring and replaced with DOCLINE, the interlibrary loan system based at the National Library of Medicine.

The midcontinent region includes more than 300 libraries in Nebraska, Colorado, Wyoming, Utah, Missouri, and Kansas, with administrative offices at the University of Nebraska Medical Center in Omaha. The Octanet system served as the prototype for DOCLINE, and Octanet staff provide "valuable input and advice" to the National Library of Medicine during the development and implementation of DOCLINE.

With the phase out of Octanet, all seven of the medical library regions will be using a common interlibrary loan system. (Overtones, March 1987)

"Poster Guys" Take on Ripley's Oddities

The "Poster Guys" -alias Robert A. Pisciotta and Mark E. Funk, heads of cataloging and collection development, respectively, at the University of Nebraska Medical Center-have completed their latest work, a takeoff on Ripley's Believe It or Not, titled Dewey's Believe It or Not. Since they took on Excerpta Medica ads in 1983, these two have been putting out a yearly poster filled with library-type jokes. They've done AACR3-D; Oldies, Libraries', Golden-Collected Works, and last year, LTV-Library Television. The LTV poster, promising "24-hour bibliographic entertainment," featured such shows as The Young and the Reference, MARC & Mindy, and Waiting for GODORT.

"We're trying to encourage, in our way, library humor," said Pisciotta, which he feels is sorely needed. The McGoogan Library pays for the printing of the posters and so far, he says, they've actually been able to make a little profit for the library.

Each 15" x 21" glossy black-andwhite poster is \$2 plus \$1.75 shipping and handling per order, checks payable to McGoogan Library of Medicine. Satisfaction guaranteed, or as they put it: "If you are dissatisfied for any reason, return the unread portion of the poster. We will return the unspent portion of your money. Checks, feedback on previous posters, and ideas for new ones to The Poster Guys, McGoogan Library, UN Medical Center, 42nd and Dewey Avenue, Omaha, NE 68105-1065. (Library Journal, May 1, 1987)



Panhandle Library System Buses to Gordon's

Nebraska's Panhandle Library System has developed an innovative approach to cooperative buying for its 74 libraries. Twice a year board member Janice Wolf and her fellow librarians charter a bus to Denver, for a shopping spree at Gordon's Books where the wholesaler holds a Saturday open house for the group.

Former PLS president Wolf says her

idea was "born out of the blues" in 1983 when the libraries were unable to satisfy the state requirements for cooperative buying. She remembers telling a friend frustratedly, "I wish I could just pack them up in a bus and take them somewhere!" By the next board meeting she had arranged dates, expenses, charter plans, a ticket price for each librarian attending, and a special arrangement with Gordon's.

By 1986 the group was planning Spring trips as well as overnight trips in the Fall. Wolf says the semi-annual event is now fulfilling the cooperative buying requirements and serves as a model for other libary systems. Word has it that a Colorado system is considering joining the Nebraska group on their next visit. (News release)

Nevada

Literacy Coalition Wins \$99,000

A project to launch Nevada's first statewide assault on adult illiteracy has won a \$99,000 grant in the Literacy Challenge, a program of the Gannett Foundation in cooperation with USA TODAY to foster coordinated, statelevel efforts promoting adult literacy. The award to the Nevada State Library and Archives creates the Nevada Literacy Coalition which will lay the groundwork for a collaborative approach to teach more Nevadans to read. The grant's goals include expanding the existing Northern Nevada literacy hotline into a single statewide network for literacy information and referral, conducting studies, providing training and materials to volunteer tutoring groups, and making the public more aware of the adult illiteracy problem. (Dateline State Library, March 1987)

Friends Celebrate Bicentennial of the Constitution of the United States

Friends of the University of Nevada Reno Library celebrated the Bicentennial of the Constitution of the United States on March 25 with a membership dinner. Guest speaker was former UNR history professor, Paul H. Smith, who has been with the Library of Congress since 1969. Smith's extraordinary endeavor at the Library of Congress is editing the papers of the members of the Second Continental Congress. To date, 13 volumes of Letters to Delegates to Congress 1774-1789 have been published.

The title of Smith's talk to more than one hundred guests was "The Joys and Rewards of Reading Mr. Jefferson's and Mr. Madison's mail." (Memo, March-April 1987)

North Dakota

\$9000 Grant for Periodicals Index

A \$9,000 grant from the North Dakota State Library under the Library Services and Construction Act Title III has been approved by the Governor's Advisory Council on Libraries for development and publishing of the 1986 edition of the "North Dakota Periodicals Index."

Announcement of the grant was made by Kenneth Behringer, LSCA grants coordinator for the State Library, and Michael M. Miller, NDSU librarian and project director for the North Dakota Periodicals Index.

The indexing project will provide access to primary North Dakota periodicals covering history, education, agriculture, business and recreation. Thirty-five librarians from across the state are indexing 51 North Dakota periodicals. Plans are to publish annual editions in 1987 and 1988 with a fiveyear edition (1981-1985) called the North Dakota Periodicals Index Centennial Edition, to be ready for publication by the fall of 1988 for the North Dakota Centennial Year in 1989.

Marketing and distribution will be conducted by the North Dakota Library Association, with any profits to be set aside for publishing future indexes.

Earlier the North Dakota Humanities Council approved a \$2,000 grant to develop the computer program for the indexing. Plans to market the indexing program are underway. (News release)

Planning for Library Automation

The Office of Management and Budget did not support the State Library's funding request for the LAND (Library Automation for North Dakota) project for the 1987-89 biennium. Two groups of libraries, however, have decided to pursue automation on local levels: the Bismarck area libraries and the libraries of the University of North Dakota. At UND, the Chester Fritiz Library (along with its branches), and the Thormdsgaard Law Library and Harley French Library of the Health Sciences have begun preparing for campus-wide library automation. A decision has been made to prepare our machinereadable records for an online catalog. A working group comprised of each library's technical services staff is investigating questions on issues like the desired MARC record format, authority control, deduplicating records, etc.

In Bismarck, the State Library, Veterans Memorial Public, University of Mary, and Bismarck State College are working on preparing their records for the same purpose. (Biomedia Report, April 1987)

South Dakota

SDLN Misses Funding

In spite of considerable effort on the part of Governor George Mickelson and State Librarian Jane Kolbe, no funds for the first phase of the South Dakota Library Network, the proposed statewide automation plan, were secured from the 1987 S.D. Legislature.

However, at a May meeting, the South Dakota Board of Regents indicated for the first time that the project shall have its full support.

While the search for funding and support continues, the SDLN Advisory Committee and various subcommittees continue to develop and refine various operational policies and procedures.

SDLN/ACCESS Receives Go-Ahead

While the work on the South Dakota Library Network has focused on the online catalogs of the regental libraries and the State Library, planning for the sharing of school and smaller public and special libraries has already begun. All SD libraries will eventually have allimportant dial-up access to the network of academic and large public and school libraries. But school and small libraries need a way of sharing their holdings with the whole SD library community. SDLN/ACCESS may be the beginning of enabling that sharing.

SDLN/ACCESS is now seeking volunteers for four continuing work committees: quality of database, delivery/share systems, continuing education, and funding-space-vendors. (BookMarks, May/June 1987)

Compact Disc Database Purchases

A database of information covering every aspect of education is now available through compact disc technology at the Karl E. Mundt Library at Dakota State College in Madison.

The Mundt Library has purchased a copy of ERIC, the database of materials collected by the Educational Resources Information Center of the U.S. Department of Education.

The Sioux Falls Public Library has added InfoTrac II, the compact discbased indexing service from Information Access, Inc. which indexes all the periodicals indexed by the Magazine Index plus the New York Times. (News releases)

Utah

THE UPGRADE PROCESS

Nineteen eighty-seven will prove to be a landmark year in Utah public library service development. For the first time in its history, Utah will see the implementation of public library standards and the granting of state funds to qualifying public library service centers.

The culmination of those efforts is represented by The UPGRADE Process: Planning, Evaluating, and Measuring for Excellence in Public Library Service (1987)

The UPGRADE Process is designed to assist librarians and library boards in planning for improved library service. One basic premise of the manual is that most libraries are, and should be, continuously seeking improvement. UP-**GRADE** provides a framework which allows libraries to structure their efforts and to reap benefits from the improvement process. The framework is structured as a Public Library Service Development Ladder. Most of the manual is devoted to describing and explaining the steps in formal planning which a library striving for Excellence will take.

This emphasis on planning The UP-GRADE Process puts Utah at the forefront of a national movement. Kathleen Blacom, president of the ALA Public Library Association told ULA Convention attendees that Utah is "three months ahead of the cutting edge," since **The Public Library Development Project**, containing the long-awaited national "standards" which involve formal planning, will not be out until this summer. (Horsefeathers, April 1987)

Libraries Receive Certificates of Excellence

Donald E. Fossedal, Superintendent of Documents, U.S. Government Printing Office, recently awarded "Certificates of Excellence" to the directors of three outstanding Federal Depository Libraries in Utah: the Marriott Library, Utah State's Merrill Library, and BYU's Lee Library.

The "Certificates of Excellence," which were awarded by Mr. Fossedal during a recent talk he gave in Utah, were awarded as a result of scores received during the official Government Printing Office inspections conducted last year. The three Utah libraries scored "Excellent" in all categories, thus placing the libraries in the top 3% of the 1,395 depository libraries nationwide. (University of Utah Libraries Newsletter, Volume 13, No. 1, 1987)

The new White Mountain Branch Library in Rock Springs features a bronze statue by Bud Boller of Dubois. "Mountain Main," which depicts a man leading his pack horse, was purchased by the Sweetwater County Commissioners for display at the library.

Commissioners paid \$13,000 for the statue although it is valued between \$30-\$35,000. Boller cast nine of the statues and John Wayne bought the first. The last one sold for \$30,000.

The three foot by three foot statue will be displayed in the lobby. Actor Charlton Heston posed for the sculpture while he was in Jackson working on a film. (Wyoming Library Roundup, Spring 1987)

professional development grants

Reflected here is an MPLA concern that members have an opportunity to continue their formal education. MPLA's Professional Development Grants Committee is charged with developing and improving library services in the region by helping individuals already employed in the library profession to expand and continue their education.

Association members are encouraged to apply for grants and mini-grants, both of which may be used for the following: formal college or university classroom work, independent study programs, attendance at workshops, conferences or seminars, or participation in any other activity that will benefit librarians and the library community in our region.

Applications are invited throughout the year, and members should recognize that each application will be considered on its own merits and the availability of funds in each year's Committee budget.

Requirements, Conditions, Procedures

Requirements for Application:

- 1. The applicant must be a resident of the MPLA region.
- 2. The applicant must be a current member of the Mountain Plains Library Association. For regular grants the applicant must have also been a member for the past two years (total of three consecutive years).
- 3. As part of the application, the applicant must submit a detailed budget of expected expenses and a narrative statement describing personal growth and career development expected for the program.
- 4. The application should be accompanied, whenever possible, by printed materials which describe the program.

Conditions of Grant:

- 1. To allow students, trustees, and unemployed members to be eligible, it is not necessary that applicants be currently employed in a library.
- 2. All applicants must agree to give the MPLA Executive Board an evaluative report on the program after it has taken place. For benefit of the membership, the evaluative report may be published in the MPLA Newsletter, or other publication.
- 3. The grant money will not be awarded until after the evaluative report has been received and approved by the Committee. The Committee chairperson will notify the MPLA Executive Secretary to make payment. The form for the evaluative report will be provided to applicants by the Professional Development Grants Committee.
- 4. No Applicant may receive more than one grant per eighteen months.
- 5. If one is received, a copy of a continuing education unit certificate or letter of recognition received upon completion of a seminar or workshop should be submitted with the evaluative report.

Application Procedure:

- Request application from Committee Chair or MPLA Executive Secretary. Beginning January 1st, completed applications may be submitted to the Executive Secretary by the announced deadlines.
- 2. The Committee will review the applications received and make awards according to the following guidelines:
 - i) The Committee may meet a maximum of 6 times a year;
 - ii) Conference calls are scheduled bi-monthly on or close to the 25th of the month. The month and dates of these calls are printed in the "calendar" of all issues of the **Newsletter.**
 - iii) The Committee will meet during the annual conference. Applications and reports will be considered at that meeting.
 - iv) The deadline for receipt of an application or report by the Executive Secretary is the 10th of the month preceding the established date on which they will be considered.
 - v) Selection for awards will be made by majority approval of the Committee.


