President's Report

A primary concern this year was to implement the number one goal of the MPLA Long Range Plans: to increase the membership in MPLA. Several ideas from the Membership/Public Relations Committee which was chaired by Connie Lamb were brought to the Board. Clever ideas to raise awareness of MPLA were membership contests: free conference attendance for the person who obtained the greatest number of memberships, free token gifts to all who attend the annual MPLAA/CLA conference, and a brochure with a new design that described what MPLA is and what it offers to the membership. This brochure would be made available to State Representatives in order to distribute it to State Association and Section Committee meetings.

The Graduate Task Force committee, which was chaired by Corky Walters, is in the process of conducting a survey to measure the market for library student graduates. This survey will be critical in the region since many students are graduating from Distant Learning "Masters in Library Science" programs. In addition, a Conference Manual is being updated and will include examples of a sample contract for MPLA/State, a sample contract for Conference committee/speaker, and a sample contract for State/MPLA hotel as well as a payment schedule for speakers. This manual will be beneficial to future conference chairs.

Plans are in the making to promote an Interlibrary Loan Interest Group. This group is chaired by Julie Wessling. Since

Pam completed her MLS in August of 1992 and currently works at the Loveland (Colorado) Public Library. This year's recipient is Francella Springer who is a student in the University of Arizona Graduate Library School. Fran works at the American Graduate School of International Management where she is in charge of Periodicals and Interlibrary Loan. She will be attending the CLA/MPLA Conference in Snowmass.

Committees

Awards Committee

The goal of the MPLA Awards Committee is to give recognition to individuals and organizations who have promoted and supported libraries and librarians within the Mountain Plains region.

The Awards Committee was charged with composing a standard nomination form. Copies of forms from member state associations were obtained and forwarded to the committee members. Members sent their comments to the chair who then used these comments to create the form. The form was presented to the Executive Board for approval at the January 1993 meeting in Denver. A copy was forwarded to the chair of the By-laws committee for consideration and inclusion in the manual.

This form was put in camera ready format and copies were sent to the editors of the MPLA and member state newsletters for inclusion in the spring newsletter. I will forward a disc with the form, and the list of these state association newsletters and current editors that I have compiled to my successor.

Nominations were gathered, and forwarded to committee members for their vote. Votes were tallied. The results were sent to Executive Board members, and are on attached sheets. Winners were notified by mail. Connie Lamb, Public Relations, chair, was sent a copy of the winners and will send each a press release to submit to local media.

The financial report cannot be completed until after the October conference. To date no MPLA monies have been expended.

Public Relations/Membership Committee

The MPLA Public Relations Committee worked very hard this past year to promote MPLA and encourage membership. Not much has been done in this area for the last couple of years and the officers and committee realized how much needs to be done concerning MPLA membership. Therefore, much of the committee's work resulted in a foundation upon which future committees can build. The following is a list of activities and accomplishments of the committee.

- 1. Developed news releases (standard forms) that can be used to announce winners of MPLA awards or activities of MPLA members.
- 2. Developed a mailing list of addresses for large library systems where we can send promotional material for MPLA.
- 3. Began a list of library publications and newspapers where MPLA activities can be advertised.
- 4. Sent an announcement of the upcoming annual conference in Snowmass to seven national library journals.
- 5. Developed two different brochures which can be used to advertise MPLA. The four-fold brochure was sent with a newsletter in July to non-members as part of a membership promotional campaign. The second is a condensed three-fold brochure; two posters were also created which can be used with the brochures.
- 6. Sent to state MPLA representatives both the posters and brochures to use at their state library conferences. Also sent them an article about the importance of MPLA membership which they can revise as needed and publish in their state newsletter.
- 7. The chairman of the committee attended the two board meetings held in Denver in January and Snowmass in May and gave reports of the committee's work and plans.
- The committee is planning to give a "freebie" at the Snowmass conference with a notice of the importance of MPLA membership.

Academic Section



papers authored by MPLA members, but an inadequate number of papers were submitted in 1993. While the papers will be presented at the 1993 Conference, publication will be delayed until 1994 when a combined proceedings may be produced. With the budget restraints and the wide-spread cancellation of serials experienced by libraries within the Association membership states, the sales of the annual proceedings have been declining. One of the problems with the publications has been the lack of a specific theme for each, so that it is difficult to market the volumes except to those with an interest in an individual paper. It has been suggested that a monographic series with topical coverage might be more marketable while still providing a forum for publication of research by Association members. Another suggestion has been that of only publishing a research volume every other year rather than every year. These options and other possibilities will be discussed at the Colorado joint conference and during the coming year.

Another complicating factor for the Research Forum during 1993 was the resignation and departure from the region of Helen Josephine, the Vice-Chair/Chair-Elect of the Academic Section and therefore Research Forum editor. We wish Helen success and happiness in her new position in Hawaii, but regret her departure at this time. After an exploration of the options available within the existing by-laws and an unsuccessful attempt to fill the position in a timely fashion, the present Chair, Mary Bushing, agreed to serve through the 1993-94 year.

Many member states are experiencing severe budget cuts in higher education. During the past year, these cuts, coupled with the crisis in scholarly publishing and journal prices, resulted in a state of siege for many institutional members. Academic librarians were occupied with massive journal cancellations and staff reductions. Recent legislative action from the membership region has not brought much optimistic news for academic and special members for the coming fiscal year. *Mary Bushing, Chair*

Sections

Public Library/Trustees Section

The goals of this year's Public Library/Trustees Section were to focus on encouraging trustee attendance at the annual conference and to provide stimulating programs geared to people representing public libraries.

At the request of trustees who attended the section meeting at the Cheyenne conference in 1992, this year's conference will include a networking luncheon so people can have more time to interact with one another and exchange ideas. A special mailing targeted at both MPLA and Colorado Library Association trustee sections was sent this summer to inform members of programs pertinent to trustees and to inspire people to come to Snowmass.

Two preconferences of interest to public librarians were submitted by the Public Library/Trustee Section. Lillie J. Dyson from the Maryland State Library (Department of Education) will present her training program on improving reference performance. Dr. Beverly Title will do a repeat half day workshop on conflict management, popular at previous MPLA and CLA conferences. She will also give a session on learning styles. State Agency, Cooperatives and Systems Section

The purpose of this section is to act as a forum for ideas among agencies and individuals with statewide or regional responsibilities and to promote continuing education. In the pursuit of these goals the section networks to communicate ideas among the members. The program we are sponsoring at the conference "From Traditional Continuing Education to Fiber Optics" will demonstrate successful education formats that can be replicated. We will work throughout the year to exchange information on successful continuing education programs.

Member States

Nebraska

The past year has been a busy one for the Nebraska Library Association and for Nebraska libraries. A number of important activities were undertaken by NLA. A dues increase was approved by the NLA membership. All membership levels will increase by \$5 except for those librarians making \$5,000 or less, whose dues will increase by \$3. NLA's Membership Committee has been working on a revised membership brochure and membership form. To increase awareness of NLA, the Membership Committee also rounded up volunteers for Nebraska Educational Television's Pledge Drive in March. The NLA Centennial Committee held a contest to find a commemorative logo incorporating the theme "Sowing Ideas Across Nebraska: Nebraska Library Association 1895-1995." The Paraprofessional Round Table has become a full-fledged section of NLA. Planning is underway for a new Information Technology and Access Round Table. Ken Oyer (Bergan Mercy Medical Library) was appointed as NLA's new Executive Director.

"Celebration of Diversity" was the theme of the Nebraska Library Association/Nebraska Educational Media Association joint convention held October 29-30, 1992 in Lincoln. The convention attracted 525 registrants. "Paradigms, Practices and Possibilities: Planning for the 21st Century" is the theme for the 1993 NLA/NEMA Convention to be held October 28-29 in Grand Island. A preconference will be held on October 27, and will include John Berry, Editor of Library Journal and Kaycee Hall, Executive Director of the Resource and Research Center of the Fashion Institute of Design and Merchandising in Los Angeles, California.

Clara Rottman, Director of Library Media Services for the Lincoln Public School System (1970-1992) received NLA's Meritorious Service Award for 1992. Nebraska Poet, Greg Kuzma, received the 1992 Mari Sandoz Award. Kay L. Paulson (Lincoln Public Schools) and Susan M. Ewing (Gering Public Library) were the recipients of the 1993 NEMA/NLA Duane Munson Scholarships.

Michael Phipps, Director of the Omaha Public Library (1983-1992), passed away on October 31, 1992 after a long struggle with AIDS. As a memorial, the OPL staff designed and made a panel for the Names Project AIDS Memorial Quilt. From April to July, the panel was on display throughout the library system and was then scheduled to be sent to San Francisco as part of the National Quilt.

The Lincoln Public Schools received a \$20,000 planning grant as one of only nine 1993 Planning Sites in the United States for the DeWitt Wallace-Reader's Digest Fund's National Library Power Project. This grant was used to submit a three-year implementation proposal, which if accepted, will provide up to \$400,000 per year towards making library media centers a "focal point for the educational program in public elementary and middle schools." An announcement from the Fund is expected in September, and if approved, the Library Power Project in Lincoln will be administered by the Lincoln Public Schools Foundation. To carry out the Project, a Library Power Director and support staff will be hired.

October 1992 saw the appearance of Nebraska Online, an electronic information service "designed to help Nebraska individuals, community groups, and businesses succeed in the global economy." It is coordinated by the Nebraska Library Commission in cooperation with the Nebraska Development Network (NDN). In addition to the Nebraska Library Commission, which is one of most prominent members, the NDN currently includes more than sixty academic institutions, private industries, libraries and state, federal, local and regional government agencies.

The summer 1993 issue of the Nebraska Library Association Ouarterly (NLAQ) was a special edition devoted to intellectual freedom. Among the seven perspectives on intellectual freedom included were an interview with Anne Penway, Assistant Director of the ALA Office of Intellectual Freedom and an account of intellectual freedom in Nazi Germany by recently retired University of Nebraska-Lincoln librarian, Elsie Thomas, who lived in German-occupied Poland and Germany during the Second World War. *Bob Nash, MPLA Representative*

North Dakota

The 86th annual North Dakota Library Association conference, "North Dakota Libraries: A Spectrum of Services," was held September 23-26, 1992 in Fargo. A preconference workshop was presented by Hannelore Rader, "Methods and Techniques of Bibliographic Instruction." Keynote address was by J. Dennis Day, "The

Second Russian Revolution—An Eyewitness Account." ALA President, Marilyn Miller, addressed the convention during the annual banquet. Ruth Evert, Edgely, received the first ever Librarian of the Year Award.

The New Dimension Information Authority is a multitype regional library system in a four-county area of northwestern North Dakota. Among its growing membership are twenty-three schools, two public libraries, and one academic institution.

In September the full catalog resources of Bismarck Public Library, Mandan Public Library and the University of Mary will be loaded onto a cooperatively purchased online system from Dynix. The new system is called INFO*LYNX, and will start with a cooperative database of over 200,000 titles.

Dakota Radio Information Service, a radio reading service for persons unable to read regular print, has been awarded a grant which will allow it to expand its broadcasting area to the Jamestown area. The grant was award by the Public Telecommunications Facilities Program of the U.S. Department of Commerce.

Oklahoma

Another busy year of Oklahoma politics, Oklahoma libraries, and Oklahoma blessings and frustrations.

One of the most note-worthy deeds accomplished this year was the hiring of Richard Wheatley as the official lobbyist for the Oklahoma Library Association. Having wrestled with the questions of why we should employ such a professional, what possible duties he might perform, under whose direction he might be placed, and (most importantly) how we might pay such a professional, the Association employed Mr. Wheatley in September, 1992. His services during the session were helpful in keeping membership informed and ready to address library issues in a timely manner.

Award-winners for children's and young adult fiction claimed their prizes at the Oklahoma Library Association Annual Conference held in Oklahoma City, March 30-April 2, 1993. Once again, hundreds of school children voiced their opinions, and gave Sequoyah Awards to Cynthia DeFelice for Weasel and Annette Curtis Klause for *The Silver Kiss*. Over 500 conference participants heard keynoters Kaycee Hale and Will Manley encourage them to "Discover the FutureExplore Oklahoma Libraries." Of special note, was the preconference on Internet which drew some 150 participants to a full-day session. This is a record for any preconference, and highlights the demand for more technologically-based training.

Progress on the Oklahoma Libraries Technology Network is painfully slow, due in part to the hesitancy of state funding through the legislature. An up-dated OLTNcat was issued in the fall, with over 7 million holdings on over 3 million records. The fiber optic linking of all sites is not yet a reality, but efforts continue.

1993 was named the year to "Celebrate Literacy!" by the Oklahoma Department of Libraries. Posters, bookmarks, and certificates were made available to any who wanted or needed them. Once again, grants for up to \$500 were made available for the purchase of high interest/low level materials. This effort continues through 1994.

As a continuation of the Joint Task Force on Public Library Certification named earlier, a similar joint committee from the Oklahoma Library Association and the Oklahoma Department of Libraries was named. Their work is only beginning, but the concept of certification has been approved; the task of implementation and procedures remains.

Oklahoma continues to work to provide high-visibility for Mountain Plains Library Association. Once again, an MPLA President was able to attend our annual conference and presented two programs. The booth display solicited a number of contestants for the free membership drawing. While our membership totals are still well below what we would like, awareness is growing as a result of two mailings to all OLA members as well as numerous articles and reports presented throughout the year. South Dakota

After careful planning from representatives of both states the University of Arizona now offers the videobased Master of Library Science degree. Classes will be available at sites in Aberdeen, Madison, Rapid City and Sioux Falls. They are delivered via satellite and videotaped for classroom use. Students and a qualified instructor meet at a regularly scheduled time to view the tape. Student access to materials and information is facilitated by the on-site instructor. Most students can complete the course work in four years with only one or two summers on the campus of the University of Arizona. Ethelle Bean is the director of the University of Arizona Library Program in South Dakota.

The 1993 Cooperative Summer Reading Program was entitled "Hooked on Books" with emphasis on fishing for great titles and great fun at the library. Libraries in South Dakota, Minnesota and North Dakota cooperated in this joint venture.

Gary Johnson, a former technical support manager for Unisys Corp., has been named Network Operations Director for the South Dakota Library Network. Gary is the first full-time network director. He began his new responsibilities in August of 1992 at the SDLN operations center in Spearfish.

At the 1992 annual Conference the following awards were presented: Jim Oliver (Sioux Falls Public Library), New Librarian of the Year Award; Ethelle Bean (Dakota State University) Librarian of the Year Award; Jane Kolbe (South Dakota State Library) Distinguished Service Award. President Raney also presented awards to Donna Fisher, Jane Kolbe, DeAnn Hilmoe, Elvita Landua and Gary Johnson.

Ann Smith, Augustana College, was chosen to visit Israel for a month visit as a member of the Rotary Group Study Exchange team sponsored by the Rotary Foundation.

Utah

As of the June 1993 membership report Utah Library Association has a personal membership of 609 and an institutional membership of 19.

This year the ULA Board appointed a Strategic Planning Task Force to assist in establishing its goals for 1992/ 93 and to recommend action the Association should take to strengthen its support of Utah's libraries and library employees. The Task Force made several recommendations, which gave the Board areas to focus on for the year.

One recommendation focused on the multiplicity of library associations in our state and the need for greater cooperation and coordination of activities. The boards of ULA and the Utah Educational Library Media Association (UELMA) met together in January and passed a number of motions that will foster a closer working relationship between the two associations. The motions passed provided for ULA and UELMA boards to meet together at least annually, encouraged changes in the dues to encourage individuals to join both ULA and UELMA, provided for a liaison between the two associations, and working together to foster greater multitype library cooperation in Utah. Plans are being made to hold a joint ULA/UELMA conference in February, 1994.

Another recommendation from the Planning Task Force was for ULA to sponsor a Great Issues Forum. Scheduled for this all, this forum will bring together government officials to discuss the future of libraries in Utah and will provide an unusual opportunity for librarians and public leaders to discuss the impact of new technology on library services.

Another of the recommendations was the ULA "Foster the best continuing education effort in any state." This led to Regional (Continuing Education) Workshops on local history collections, basic cataloging, computer basics, reference hints and helps, young adult programming, children's storytelling and a variety of other topics. The workshops were presented in four different areas of the state, allowing over 150 librarians from all around the state to be trained.

Last of all, the annual ULA conference was held in Cedar City, May 12-14, with 271 attendees, 40 sessions and activities, 69 presenters, and 38 exhibitors. The conference offered a broad diversity of activities...from workshops and sessions on the Utah Library network, effective leadership, achieving excellence, serving service providers, discussing the future of scholarly communication, and an engaging keynote address by Leslie Norris, to a prime rib dinner with a Shakespeare Costume Cavalcade and a 5K fun run. The following awards were presented at the conference: Sandra Collins, Associate Director of the Weber County Library was presented the ULA Distinguished Service Award; Warren Babcock, Reference Librarian at the Merrill Library, Utah State University, was presented the Librarian of the Year Award; Mary Southwell, Director of the Murray Public Library received the ULA Special Recognition Award; The Book Group received the Special Service to Libraries Award; and Deanna Adams, MLS student at Brigham Young University received the Baker & Taylor Grassroots Grant Award.

Vickie Turner, Margaret Baca and Joan Thomas received the ULA/Certificate of Achievement for Paraprofessionals.

The year has been progressively effective in both large and small ways in improving the effectiveness of both the state's libraries and librarians. Gwen Page, MPLA Representative

Wyoming

The search continues for a Wyoming State Librarian. Although several candidates have been interviewed, none was selected and the position remains open. Jerry Krois has served as acting state librarian since the resignation of Suzanne LeBarron last spring.

Pathki Nana by Ken Thomasma was selected to receive the Indian Paintbrush Book Award by 598 elementary students. Runners up were Doll in the Garden by Mary D. Hahn and Totally Disgusting by Bill Wallace.

Four library employees received Nora Van Burgh Development Grants to attend classes or workshops. They were Alice Meister of Sheridan County Fulmer Public Library, Marsha Bradbury of Natrona County Library, Sue Knesel of the Campbell County Public Library and Mary Rhoads of Johnson County Library.

Efforts to pass legislation that would allow counties to form library districts were unsuccessful. Despite a very active campaign, much of it from grass roots supporters, the mineral industry proved to have a stronger voice.

Prompted by a cash flow problem, WLA will hold an auction of donated items at their annual conference to be held in Rock Springs October 13 through 16. Items range from needlework and books to GEAC linking, services and supplies. It is at this conference that a new MPLA representative will be announced. Marcia Wright, MPLA Representative

The Information Broker's Seminar

A report by Jim Dertien, City Librarian, Sioux Falls, SD, on The Information Broker's Seminar by Sue Rugge and The Information Professionals Institute, a seminar offered fifteen different times in the U.S. and overseas in 1993, and one which will probably be offered with the same frequency in 1994 and subsequent years.

If, on occasion, you have considered the possibility of leaving the library profession and entering the for-profit sector as an information broker then perhaps you may want to read on. I recently spent one day in Chicago with Sue Rugge and fourteen others receiving the training that Sue's firm has developed for beginning information brokers.

Why was I there? Several reasons. Probably like you, I was curious. It would be unnatural for a young old-timer like me not to wonder what life might be like outside of municipal government. I was also seeking ideas that I could adapt to my own public library operations so we could be more sensitive to the increasingly sophisticated needs of our clientele. And, finally, I felt that a better understanding of information brokering would be useful in developing contacts and contracts for these services when my library needed the expertise in order to assist our own customers.

This seminar emphasizes the business side of brokering. Online searching and the accessing of public records are covered in two other seminars, frequently held in conjunction with this one. Sue Rugge's credentials as one of the founders of information brokering make her a natural to conduct this training. She has not lost sight of the uphill effort new business start-up requires, and she has consistently been a leader in this business. She founded Information Unlimited in 1971 and later went on to found Information on Demand, both being very successful. Today she is a principal in The Information Professionals Institute and she is the director of The Rugge Group, a coalition of information specialists providing information brokering services.

Before discussing the training I received, I would first like to share a few observations gleaned from discussion during the seminar. At an annual income of an estimated \$50 million for all information brokers in the United States, it is obvious that this is still a very small field. In another direction, information brokers have discovered that librarians feel threatened by their presence and their potential, sometimes worrying about the impact on their relations with their existing customers or sometimes simply being jealous. Actually, experience has shown that there is little to fear, and that there are really advantages to having good relations with brokers, either in your community or elsewhere. The relationships are naturally complimentary. Often, for instance, librarians refer client's needs to brokers in situations where they do not have the time or expertise or the materials necessary to do the work.

The seminar attracted an interesting group, including ex-librarians, active librarians, professionals from engineering and other technical fields, a couple of practicing information brokers, and an owner of several successful women's clothing shops who was just discovering her fascination for computer searching. As I understand, the make-up of this group was typical of most of the seminars. The presence of practicing brokers was valuable for the types of questions they asked and discussions they started.

Ms. Rugge's seminar is fast-paced, thorough and complete. She provided extensive handouts organized in a binder, plus brought to the seminar samples of a number of key journals, other publications, and promotional items from information brokers currently doing business.

As I noted earlier, this seminar covered the business end of information brokering. This includes analyzing your potential, developing a business plan, other start-up details, record-keeping, partnerships, taxes, billing and fee-setting, marketing, and much more. In an ideal situation, Ms. Rugge recommends that a new firm be started by two people, one to handle the business matters and one to do the research. In order to succeed, a firm must have a regular flow of business, so each day's work must include contacts with not only old and current customers, but with potential clients. Solo brokers find it very difficult to meet research deadlines and at the same time maintain these contacts and keep up with all the other business routines.

During the day many first-rate tips were provided, which give an edge toward being successful. An example of a simple, but effective, suggestion was the one offered by one of the new brokers attending the seminar. He had his wife record his business phone answering machine message, thus giving a caller the impression of an operation involving a staff. It was also noted that you should have a business phone line which is separate from your home phone line if you

work out of your home.

Ms. Rugge showed many examples of how not to prepare promotional literature, and similarly, examples of how it should be done. She showed a constant awareness of the impact of start-up costs and what most people can afford when starting a business.

The seminar included a lot of emphasis on marketing and a similar amount of emphasis on how to maintain your firm's integrity.

While librarians bring with them training and experience that can be useful in this kind of business, they do not necessarily bring with them other advantages. Whatever your background, you must understand there are risks. Starting a business can be a complicated, but gratifying effort. You must understand that you will suddenly become totally responsible for securing income to keep your business going, and for providing employment for yourself and possibly others. The hardest work comes at the beginning, when you see your savings being drained by start-up expenses and you wait for your client base to grow. While this is not for everyone, those who have succeeded would not give it up for anything. Ms. Rugge takes a great deal of pride in the work she has done and the work being done by others who make up the small membership of the Association of Independent Information Professionals. One participant, a broker specializing in chemical engineering research, said, "The only thing worse than keeping a mistress is being an information broker." Fortunately, his wife helps him with his business, so she understands the long hours and seven-day weeks.

Did I go away satisfied that my curiosity and some of my questions had been answered? Certainly! This seminar gave me an opportunity to give concentrated attention to a fascinating career alternative, and to learn what makes information brokers tick. Have I applied anything I learned? Well, not yet. I wrote this report the morning after completing the seminar, so you will just have to check with me later.
