## Leadership Institute 2003 Applications Begin

Deadline for

application is

May 31, 2003!

Application forms for the 2003 MPLA Leadership Institute to be held November 9<sup>th</sup> to the 14<sup>th</sup> at beautiful Ghost Ranch in New Mexico are now available at the MPLA Website (<a href="www.usd.edu/mpla/leader-ship/">www.usd.edu/mpla/leader-ship/</a>). MPLA is interested in finding "the best in the west" to participate in the Leadership Institute and encourages anyone who wishes to enhance their leadership abilities and to network with others who are

also potential leaders to apply for consideration for one of the institute positions.

Nationally recognized consultant and trainer Maureen Sullivan will once again be the primary speaker

at the 6-day event. Six mentors selected from the MPLA membership will assist her in the leadership development work. Mentors provide their time and expertise as a professional service to the association. They participate in the entire Institute and make themselves available throughout for consultation with individuals or groups. During the Institute participants and mentors also have an opportunity to hike, explore the Ghost Ranch venue, and learn about the region's history and geology.

To be eligible to apply for one of the limited positions an individual must have an MLS or equivalent master's degree relevant to the library field along with less than 10 years post-master's work in a library related job. One must also be employed in a library organization in the 12 state MPLA region, be a current member of one of MPLA's 12 affiliated state library associations, and have a record of experience (includ-

ing non-library) that demonstrates leadership potential. Applications are completed and submitted online and will be accepted from now until midnight on May 31, 2003. From among the applications, a committee in each state will select two candidates to be invited to the Institute and the MPLA Leadership Committee will then select an additional five individuals based upon the recommendations of the state evaluation

committees. The final position in the Institute roster will be filled by an individual from our founding partner, Ebsco Information Services, Inc.

Those selected to attend the In-

stitute will be notified by Aug. 15<sup>th</sup>. Deadline for receipt of registration fee is Sept. 15<sup>th</sup>. Registration costs are \$450 with a \$100 discount for MPLA members of record since at least 2002. Their costs are \$350. Individuals invited to participate are also responsible for their transportation to and from the site. Many state library associations have assisted those invited to attend by paying in whole or in part for their transportation costs.

MPLA members are encouraged to apply themselves if they meet the criteria and to recruit appropriate individuals from their libraries and state association memberships. To be selected to attend is an honor and a privilege. The first MPLA Leadership Institute, held in November 2002, was an overwhelming success partly because of the high quality of the participants. There is every reason to suppose this one will be just as successful if "the best in the west" attend!

## Public Library Chair Chooses his Board Choice Award

Robert Banks, Chair of the MPLA Public Library/ Trustees Section would like to nominate Jeffrey Dawson for a Board Choice Award. Jeff is currently the Adult Services Supervisor at the Topeka and Shawnee County Public Library. He inaugurated the Business Librarian program at TSCPL and was very successful at developing relationships with the local business community. Jeff spent the early part of his career in Ohio, Illinois, Iowa, and Arizona working in a number of different academic libraries. An early mentor suggested that he would be an excellent public librarian. Jeff took that advice and has been an outstanding member of the TSCPL staff. He is enthusiastic and creative in his approach to librarianship. Jeff is interested in MPLA and is looking forward to becoming active in the association.

## First MPLA Leadership Institute a Huge Success!

The evaluations from the 29 participants, the six mentors and the consultant/trainer all indicate that the first MPLA Leadership Institute held at Ghost Ranch in New Mexico in November 2002, was a huge success. The responses from both written and verbal evaluation questions, as well as on-going comments from participants send a clear message – "It was great!"

Highlights from the evaluation report prepared by consultant Dr. Mary Bushing, include overwhelming satisfaction and downright delight with the content, materials and presentation by trainer Maureen Sullivan as well as great appreciation for the six MPLA members who served as mentors for this first institute. Of Maureen Sullivan attendees said, "Excellent, ideal, awesome, knew content, was professional." About mentors, they said, "Loved the mentors, mentors were great, really an asset, appreciated their time and talents, complemented Maureen, one of most valuable aspects." In addition, participants raved about the natural beauty, isolation, and opportunities for bonding provided by the Ghost Ranch location even if their initial fear of radical technology isolation made them a bit hesitant to let go of their cell phones and e-mail accounts. New friends and mentors as well as lots of content to enhance leadership potential filled the days and made the time pass all too quickly for many. As one participant put it, "Best thing I have ever been to!" And another said, "A real 'no-BS' workshop. I really learned something!"

Participants were also in agreement that the Ghost Ranch environment did offer some challenges and was not the Ritz! Ghost Ranch, situated just outside of Abiquiu, New Mexico is the National Adult Study Center of the Presbyterian Church, U.S.A. and is a fairly typical western "church camp" with a homey, relaxed environment that extends to sleeping accommodations and meals. Layered camp clothes were the uniform of the day with hiking boots or study

walking shoes a must. Participants awoke the first day to a couple of inches of snow and a chilly walk to the dining hall for that first cup of coffee! As with so



many things, being prepared for the ranch rather than room service made all the difference. Future participants will benefit from many of the practical suggestions made by the 2002 attendees. Such suggestions included advice to bring a reading light in case your roommate really does want to sleep while you pursue your mystery or course work, and not to forget warm gloves and sunglasses since temperatures in November at that elevation can range from 0 to 65. Other practical advice offered by the attendees and mentors included lengthening the Institute slightly and providing more daylight hours for fun by holding some short evening sessions. The Leadership Institute Committee has considered these and all other suggestions and they are implementing many of the suggestions for this year's Institute in the belief that continuous improvement is the goal. The 2003 MLA Institute will be one day longer, will have more daylight free time, and attendees will get lots of practical advice about "church camp" life prior to attending.

Everyone who benefited from the 2002 Institute also wanted to be certain that our underwriting founding partner, Ebsco Information Services, Inc., be thanked for their generous support of the program. 

## **Employment Law**

Employment law is a broad area including all areas of the employer/employee relationship and consists of thousands of Federal and state statutes, administrative regulations, and judicial decisions. Wading through the information can be daunting for the small businessperson, so I have gathered some of the best Web sites on employment law. Read on...

## **Employment Law Information Network**

www.elinfonet.com

The Employment Law Information Network is an employment law portal site containing thousands of links to employment law content on the Web. This site contains links to U.S. employment law statutes and regulations, employment law articles, and example human resource policies, forms, and contracts. The site also contains a discussion forum where visitors can post their employment law questions.

#### **BenefitsLink**

## www.benefitslink.com

BenefitsLink is one of the oldest law sites on the Web. It offers compliance information and tools about employee benefit plans sponsored by private or governmental employers in the United States The site contains recent articles on employee benefits, links to key government documents, and an "ask the experts" Q&A forum.

## **U.S. Department of Labor**

www.dol.gov

The U.S. department of Labor is responsible for the administration and enforcement of over 190 federal statues, covering areas from wages and house to family and medical leave. The DOL's Website contains a vast array of legal compliance information, including "elaw Advisors" – interactive tools that provide information about federal employment laws.

Context provides a vast range of legal material on CD-ROM and on the Internet. From an employment law angle, it provides the Internet version of the official employment law case reports, known as ICR, produced by the Incorporate Council of Law Reporting.

## U.S. Equal Employment Opportunity Commission (EEOC)

www.eeoc.gov

The EEOC is the primary federal agency that enforces the U.S. employment discrimination statutes (protecting employees from discrimination on the basis of protected traits like race, sex, age, and disability status). The Commission's site includes a wide variety of primary source documents on U.S. employment laws, including statutory and regulation text, enforcement guidance, and the Commission's compliance manual. Information is available for both employees and employers, much of which is written in non-technical terms for the layman.

Findlaw, the legal media site (now owned by West Group) contains information and links to information on virtually every aspect of U.S. law, including employment law. The employment law section includes links to databases, government agencies, sample legal documents, employment law articles, and related Websites.

## WorkIndex

WorkIndex.com provides a comprehensive index of workplace related Websites (over 3,000) as well as human resource tools and information. The site is produced and maintained by the publishers of *Human Resource Executive* magazine, in cooperation with Cornell University's School of Industrial Labor Relations. It offers business book abstracts, book reviews, a salary calculator, HR news and a place to test HR software. Users can consult a legal clinic, post and search jobs, and read best practice reports.

# Soo-eee! Laramie County Kids Meet Library's Reading Challenge

Thanks to kids meeting a large challenge in "Reading Counts," the tremendously successful winter reading program at Laramie County Library System, Wyoming, County Librarian Lucie Osborn kissed a pig.

The library asked students in grades K-12 to read ten books between Nov. 20 and Jan. 23. If students read at least 100,000 pages, Osborn would kiss the pig. With more than 300 Laramie County students completing the requirement, participants read 239,000 pages.

Because kids held up their end of the bargain so well, Judy Norris, the library's outreach coordinator, also kissed the pig!

Nearly 200 people, including several local media figures, witnessed the big smooch, appropriately held on Valentine's Day.

Everyone who finished the reading program received a prize and two participants won a drawing for gift certificates from local merchants.

This program was offered in conjunction with Go Figure!, a national traveling exhibit for children. More than 4,700 people visited the exhibit during its stay in Cheyenne.

This memorandum of understanding establishes the basis for mutual understanding and cooperation between the Library Associations of Washington, D.C., Virginia, West Virginia, Maryland, Pennsylvania, Ohio, Kentucky, Indiana, Illinois, Missouri, Iowa, Kansas, Nebraska, South Dakota, North Dakota, Montana, Idaho, and Oregon - hereinafter referred to as the Trail States Library Associations - and the U.S. National Park Service (NPS).

This memorandum summarizes how the parties intend to create an alliance for the purpose of the creation and implementation of the Corps of Discovery II project for the National Lewis and Clark Bicentennial commemoration. The parties will engage in working together to expevided by the designated representatives from each state and their committees, with Cheryl J. Heser of the Montana Library Association acting as liaison for communication between the Trail States Library Associations and the National Park Service representatives.



## Public Relations and Local Marketing Assistance

In cooperation with the designated Public Information Officer for the National Park Service, the Trail States Library Associations will work with a network of libraries in the locations chosen by the National Park Service for presentation of Corps of Discovery II. They will assist those libraries in providing or assisting with local publicity for the town meetings and for the visit of Corps of Discovery II. In many cases, the libraries in the network can simply coordinate efforts with the local Chambers of Commerce and other entities with an interest in the Lewis and Clark Bicentennial observance. Examples of activities might include providing articles to local newspapers, notices to local radio stations, distribution of posters or brochures, and special invitations to groups or individuals to support or enhance the meetings or visits.

## **Local History and Story Telling**

One important aspect of library involvement in the visits of Corps of Discovery II throughout the Trail States is to take advantage of the opportunity to supplement the program with local history exhibits and activities, some connected with the Lewis and Clark Expedition and others related to other local history. The Trail States Library Associations will encourage and facilitate library involvement in promoting local history.

The National Park Service also considers storytelling, both related to Lewis and Clark and to other local history, an important part of the Corps of Discovery II mission. The Trail States Library Associations can assist in encouraging and facilitating library participation in providing places for storytelling and promoting local participation.



## Promotion and Dissemination of LewisandClarkgnet.org

The Trail States Library Associations will collaborate with the Peter Kiewit Institute and the National Park Service in promoting the <u>LewisandClarkgNet.org</u> Website. This promotion will be accomplished through dissemination of brochures, links on Websites where appropriate, and referring students and the public to this resource. The Website will feature searchable online databases along with traditional resources; online digital videos of presentations and interviews from Corps of Discovery II as it travels along the Trail; and GIS systems that will provide user-friendly navigation to all of the above. Furthermore, all members of the Trail States Library Associations are encouraged to submit new resources to the site, to post reviews of the existing resources, and to give feedback to the LewisandClarkgNet.org staff.

## Conditions of Trail States Library Association Involvement

It is understood that the principal role of the Trail States Library Associations in this cooperative agreement is to establish committees to provide communication and leadership for libraries in communities involved with Corps of Discovery II. The Associations cannot guarantee any level of individual library participation, although every effort will be made to enable libraries to participate and to foster a positive attitude of enrichment and opportunity from this cooperative effort.

## Around the MPLA Region

## ARIZONA

Library school saved! -- The School of Information Resources, University of Arizona (SIRLS) has been removed from the "proposed elimination list." SIRLS was one of 16 programs in the University proposed for elimination in the wake of major budget cuts last January. SIRLS prepared a comprehensive business plan that describes the means for SIRLS to achieve a measure of self-sufficiency. That plan, together with sustained and vocal support from alumni, employers, students, colleagues and organizations around the country led the President and Provost to issue the following statement:

"The Masters Program is the largest in the College, and one of the largest in the University. It is the only accredited Library and Information Science program in Arizona and in eleven other mountain states. The School has a long history of educating Hispanic and Native American Librarians and its Knowledge River program has been cited nationally as a model for the recruitment and education of minorities in the information professions (Library Journal, October, 2002)... We have reached the conclusion that SIRLS should not be eliminated."

## **COLORADO**

World champ leads libraries into second century of service -- After a nationwide, six-month search, the Pikes Peak Library District (PPLD) Board of Trustees appointed José A. Aponte as executive director of the library district in December 2002. He assumed the position on Jan. 8, 2003. Aponte was selected to succeed Patrick Losinski, who became director at the Columbus (Ohio) Metropolitan Library in June 2002 after serving PPLD for four and a half years.

"With over 23 years of experience in libraries in Arizona, Florida, and California, José was the top candidate in our nationwide search," reported Tom Herd, library board president, "He will be a tremendous asset to our library district as we seek to improve services and establish new libraries to meet the growing demands of a second century of service to our El Paso County residents."

Since 1996, Aponte has worked for the City of Oceanside (California). most recently as Deputy

City Manager in charge of Neighborhood and Community Services, responsible for the administration of Library Services, Parks and Recreation, Housing and Neighborhood Services, and Code Enforcement. Prior to assuming that position in 2000, he was director for the Oceanside Public Library. His library career also included serving as director of the West Palm Beach Public Library (Florida) and Principal Administrative Librarian, San Juan Capistrano Regional Library (California).

In accepting the position at PPLD, Aponte says, "As an experienced leader in our profession, I am drawn to the potential of this outstanding library and community. It is no secret that the Pikes Peak Library District is recognized by its peers for exemplary planning models, which incorporate residents, staff, trustees, and management teams for highly effective service delivery." Just this year - in June - Aponte received a White House appointment to the Laura Bush Foundation for America's Libraries Advisory Council. In addition to library leadership, Aponte is the current world duathalon champion in his age group (50-54). In Austria this past August, Aponte finished 75 out of 1.000 male and female athletes from around the world in this run-bike-run event sponsored by the International Triathlon Association.

Aponte earned his Bachelor of Arts degree from Bard College (New York) and a Masters of Library Science from the University of Arizona. Aponte and his wife, fine artist Cynthia Reyes, have two sons.

Library funding in Colorado -- Library funding continues to be a critical issue. Due to the very tight state budget situation, CAL decided not to host the usual Legislative Day in February. Instead a CAL-athon was held in January. The goal was to have 15 contacts per state legislator from library supporters. The campaign was very successful with 94% of Senators and 86% of Representatives being contacted. Blue Spruce Award -- A Walk to Remember by Nicholas Sparks is the 2002-2003 winner of the Colorado Blue Spruce Young Adult Book Award. The Colorado Blue Spruce Young Adult Book Award is unique in being a state book award nominated and selected entirely by middle and high school students.

School library survey—2002 results available online -- Results from the 2002 Colorado School Library Survey are now available online from the Library Research Service's Website at <a href="http://www.lrs.org/">http://www.lrs.org/</a>. Over 600 Colorado school libraries responded to this year's survey. The information gathered in the annual survey provides all library professionals with important statistics for planning, evaluating, and budgeting. The Library Research Service's Website also contains information about Colorado Libraries and the Digital Divide and statistics pertaining to types of libraries.

School research topics bibliography available -- The Colorado State Publications Library recently updated the popular list of Websites from state government agencies that are useful for K-12 students doing research papers. ## **KANSAS**



SLIM doctoral program adapts to include distance participation -- Building on the long-term success of taking its Master of Library Science degree program on the road to states in the western half of the country without local programs, the School of Library and Information Management (SLIM) of Emporia State University is prepared to do the same with its doctoral program starting this fall.

In order to allow students to work towards the doctorate from anywhere in the country, SLIM will implement an Internet-based video conferencing system and provide backup with telephone bridging. Seminar courses will move from meeting for three weekends over the course of a semester to a customizable format to best suit the needs and learning/teaching styles of information professionals. Under the new plan, classes may meet for no more than one weekend or the class time may be broken up into smaller segments and distributed over the course of the semester at the discretion of the instructor. The balance of each course will be highly individualized and interactive more along the lines of traditional tutorials. The seminar classes will utilize a combination of: (1) telephone/video conference calls: (2) Internet chats on WebCT: (3) electronic bulletin board discussions; (4) individual phone conferences between instructor and student; (5) individual e-mails between instructor and student; (6) paper correspondence; and (7) collaboration software.

Since 1987 SLIM has responded to the call of the library and information profession to help educate qualified professionals unable to relocate to a local campus for a traditional learning experience. Nearly 800 individuals from Iowa to Oregon and from New Mexico to North Dakota have earned their MLS

degree from SLIM without ever needing to attend class on the Emporia campus. In typical SLIM fashion, a groundbreaking and innovative plan to offer the PhD in Library and Information Management will start with the fall semester of 2003.

In order to facilitate this evolution in its doctoral program, a program administrator will assist in student advising, coordinate student recruitment, schedule course offerings and locations, and work with faculty to design curriculum delivery options conducive to student participation from anywhere in the country. SLIM will market the program on a national level and admissions will be limited to 10 new doctoral students per year. The program requires 52-58 hours beyond the master degree. Tuition is \$175 per semester credit hour for Kansas residents and \$350 per semester credit hour for non-residents (pending approval). Salina Director earns national honor -- The Salina Public Library is proud to announce that Joe McKenzie, Library Director, has been named as the 2003 Outstanding Supporter of Support Staff by *Library Mosaics* magazine. Joe will be featured in an upcoming issue of *Library Mosaics* and will be presented with his award at the annual COLT banquet June 19 in Toronto, Canada. Joe was nominated for his tremendous support of his staff as well as contributions to library staff throughout the state with the development of SMART.

Sedgwick County libraries form partnership -- Thirteen public libraries serving Sedgwick County communities and residents have received \$70,000 for a program aimed at widening participation in children's summer reading programs countywide. The Celia and Leonard Levand Library Trust pledged the amount to fund joint programming, publicity, incentive prizes, and volunteer recognition awards.

The Levand Trust has benefited the Wichita Public Library for several years. When trustee David Broomfield suggested the need to include other libraries in the Trust's awards program, Wichita Public collaborated with three other local libraries – Clearwater, Derby, and Haysville – to see if a pilot program could work. All four libraries benefited from coordinated programming, and the cost savings generated from the cooperative purchasing and scheduling. "Bulk purchasing of prizes and volunteer recognition awards were impossible for smaller libraries working alone," said Julie Linneman, Programming and Outreach Coordinator for the Wichita Public Library.

MONTANA

Offline a success -- The annual retreat for the Montana Library Association (MLA) Offline Interest Group, took place Feb. 20-22 at the Great Falls Public Library (MT) with 65 enthusiastic participants. Offline is a Group concerned with networking and computing in the Montana Library community.

Presentations at this year's Offline dealt primarily with security issues at both the public PC level and at the network level. Two pre-conferences on Feb. 20 dealt with virtual reference and Sirsi reports. As always, there were plenty of opportunities for fun and food, as well as the best personal networking available in Montana. A highlight was dinner in the library, complete with music and a trip to the Sip 'n Dip (can you say mermaid?), recently voted among the world's ten best bars by *GQ Magazine*.

#### NEBRASKA

Kilgore recevies grant for new furnishings and programming – Reaching more kids with better services is Robin Brooks' goal. And the children's librarian at Kilgore Memorial Library says she'll be able to do exactly that, thanks to a grant the library recently received. Kilgore is one of 16 public libraries in the state to be chosen to receiving funding through the Excellence in Children's Services grant provided by the Nebraska Library Commission.

NLC Director Rod Wagner said the \$4,750 award was part of \$34,535 to be distributed across the state for innovative public library projects for children and young adults.

The program is designed to encourage creative thinking, risk-taking and new approaches to address the problems and needs of children and young adults in the community.

Part of the funding has already been used to purchase colorful banners, a helpful story-telling easel, book and magazine displays, and kid-sized bean bag chairs for the library.

In addition, Brooks said the funding will go towards programming, including providing an opportunity for York College Children's Literature students to work as volunteer mentors in activities such as story times and the summer reading program. With the college students' help, Brooks is anticipating that the library will attempt its first youth summer reading program.

Kilgore will also be using part of the funding in a partnership with Youth Leadership York to develop youth leaders and in an outreach to students at Nebraska Evangelical Lutheran High School who are in York on Saturday afternoons.

"This grant money enables us to begin needed programs and try projects that we have previously been unable to attempt," Brooks said. The new programming opportunities are expected to begin later this spring.

"One Book, Many Stories" -- Want to get hooked on a good book? How about an armchair excursion to a tiny Nevada town that exudes character and entertaining stories? January through March 2003, Western Nevada Community College and the public libraries of the seven counties the college serves presented "One Book, Many Stories," a community reading project where residents throughout western Nevada read the same book, then gather for discussions, and also brought the author to various local communities for a lecture series.

The chosen book was *Mountain City*, a colorful and easy-to-read memoir about growing up in a tiny northeastern Nevada town – population 33. Author Gregory Martin received the Washington State Book Award, The University of Nevada's Silver Pen

Award, and the work was named a *New York Times* Notable Book.


The 193-page book is a collection of vignettes and wise and humorous observations on Mountain City and its inhabitants, including Martin's Basque family. The town is filled with eccentrics, philosophers and comedians, and one cat that was found as a kitten, frozen solid to the porch of the family store until it was saved by Martin's aunt. The cat lived in the store for 19 years, always healthy and confident, "despite her missing tail, ears and toes."

Six hundred copies of the book were distributed through local libraries to book clubs and other interested readers. The book was also used in some spring 2003 English classes at WNCC and area high schools. Book clubs, high school and college classes, and many local residents will all be reading and discussing *Mountain City*.

"One Book, Many Stories" culminated March 17-20, when Gregory Martin made several appearances in Carson City, Lyon, Churchill and Douglas Counties. At these appearances, Martin read from the book, signed copies and answered questions.

New children's wing --The Lied Children's Wing of the Round Mountain Library was dedicated Oct. 19, 2002. It exists due to the financial support of the Lied Foundation and support from the taxpayers of the district. The majority of the tax money used came from the Net Proceeds Tax paid by the Round Mountain Gold Corporation, support from the library patrons and the dedication of the Smoky Valley Library District Board of Trustees and the employees of the district.

Born during the gold excitement of the 1900s, the first Round Mountain mining company



## **NEW MEXICO**

New Mexico losing state librarian -Benjamin T. Wakashige, who has
served as the State Librarian for
New Mexico since 1988, will
leave his position in May to take
a position as the Director of the
Library at Pacifica College in Forest Grove, OR. Wakashige has
been instrumental in improving
libraries in many ways such as



working for the \$16 million bond issue for school, public, and academic libraries that was passed overwhelmingly in November, 2002. He has been responsible for a statewide database for periodicals that all public and all high school libraries in the state receive. He also started the NM Task Force for School Libraries which has accomplished writing standards and funding for these libraries.

USA Patriot Act in NM -- Both the New Mexico House and Senate are sponsoring joint memorials that would address the USA Patriot Act. House Joint Memorial 40 declares opposition to federal measures that infringe on civil liberties. The memorials call for libraries to post a prominent notice to patrons that records of books they check out could be provided to federal agents and that, under the Patriot Act, librarians are forbidden to inform patrons when this happens.

New Mexico Union List of Serials project -- The New Mexico State Library is coordinating an effort to establish a Union List of Serials in OCLC's Worldcat database.

Laura Gilpin in Rio Rancho --Laura Gilpin, a native Westerner, was a professional photographer who had mastered the techniques of landscape, portrait, still life, commercial, documentary, and aerial photography as well as the principle and extant methods of printmaking. She packed her equipment on horseback to photograph the source of the Rio

Grande, did studio portraits for society matrons, and flew low to capture the light and shadows on Shiprock from every possible angle. She did her work for 55 years before gaining widespread national recognition for it. In addition she published several books for which she was photographic illustrator, writer, and designer. She was a Renaissance woman, both accomplished and advanced in the realms of practical skills, artistic vision, social attitudes, and racial politics. She is said by those who knew her to have "filled the room" with her presence. In this one woman show Deborah Blanche. New Mexico actor and storyteller, will portray Miss Gilpin as she was in the year 1954 – a confident and ebullient woman in her early 60's. Miss Laura Gilpin, as portrayed by Blanche, in "Laura Gilpin, Photographer," is on Saturday, March 15 at Rio Rancho Public Library.

Award for NM Center for the Book -- New Mexico Center for the Book wins the Boorstin Community Service Award, Center for the Book Director John Y. Cole announced. The New Mexico Center for the Book, one of the national center's 49 state affiliates, has received the first Boorstin "Community Togetherness Award," the award named for Librarian of Congress Emeritus Daniel J. Boorstin and his wife, Ruth Boorstin. Boorstin was the Librarian of Congress from 1975-1987 and established the Center for the Book in 1977. To mark their recent 61st

wedding anniversary, the Boorstins gave the national center a gift of \$6,100 to be presented to a state center that demonstrated unusual success in involving different parts of the community in its reading and literacy promotion programs.

"One of our smaller but most dedicated state affiliates, the New Mexico Center for the Book has brought national outreach projects such as Letters About Literature and River of Words to small towns and communities throughout the state since 1996," said Cole.

The New Mexico Center for the Book will use funds from the Boorstin award to help support two new projects for young people: Poetry in Place and Creative Writing in Place, which will be hosted by libraries in rural, difficult-to-reach towns and American Indian reservations.

## NORTH DAKOTA

State librarian testifies -- The North Dakota State Library testified before the North Dakota State House Appropriations Committee on Feb. 27 concerning the state library budget. State Librarian Doris Ott testified before the committee of the whole at the end of the DPI budget overview. When questioned about the apportioned one cent per pack of the state cigarette tax going to state library aid. Ms. Ott stated that the North Dakota State Library has never received the full amount it was supposed to receive. The budget hearing gave

NDLA the opportunity to invite legislators to their booth that was set up in the Great Hall on Feb. 28. The booth featured the services that the state library provides and the databases which both the state library and NDLA are requesting funding for.

Librarian receives national scholarship -- Naomi Frantes is the recipient of a \$3,000 national scholarship awarded by the American Library Association Government Documents Roundtable. The W. David Rozkuszka scholarship is awarded annually to one librarian across the United States, who is currently working with government documents in a library, and working to complete a master's degree.

Frantes is currently working toward her Master of Library Science degree through Southern Connecticut State University. She is employed as manager of State Document Services at the North Dakota State Library, where she has worked for twelve years. Frantes will use the award to pursue her lifelong dream of getting her masters degree in library science. "I love library work and am honored to be the recipient of this scholarship. Government documents are a valuable information resource." She plans to finish her MLS degree by May 2004.

She was selected for the scholarship based on her strong writing skills and her contributions to other students pursuing their MLS degrees.

This award was established in 1994, and is named after w. David Rozkuszka, former documents Librarian at Stanford University.

Workshops focus on online catalog --The North Dakota State Library is offering a series of workshops this summer. Graduate credit is available through the North Dakota State University (NDSU).

They will focus on all aspects of the statewide online library catalog including: the Online Dakota Information Network (ODIN), Gale Group's Periodical/Reference Package, ProQuest newspaper database, Electric Library2, and netLibrary electronic books collection.

The workshops are scheduled in Minot, Jamestown, Devils Lake, and Dickinson. 

The Brookings, SD academic, public, and school library support staff celebrated their 5th annual Library Support Staff Day with a luncheon on April 3. Guest speaker was Stephen Van Buren, H.M. Briggs Archivist Librarian and South Dakota State University Archivist.

## UTAH

Gorgeous new library in SLC -- The new, spectacular Salt Lake City Public Library opened Feb. 8, 2003. Voters approved an \$84 million bond four years ago. The library has six floors with a fireplace on each floor, 240,000 sq. ft., an outdoor amphitheater, meeting rooms, retail shops, an outside ramp leading to a roof-top garden, and underground parking.

Architects used much natural light, with spacious windows for panoramic vistas of the Wasatch Mountains.

Self-checkout machines speed patron transactions. The technology center is equipped with 140 computer workstations, and the library houses one of four Gates Library Training Labs found in Utah. The library collection exceeds 500,000 items. An art gallery features the works of local artists. A 320-seat

auditorium gives public space at the heart of downtown Salt Lake City.

## **WYOMING**

Inspired by Leadership Institute --Wyoming State Library has teamed up with Salt Lake Community College in Sandy, UT to offer a library technician certificate program class online at Utah resident rates. Lesley Boughton, State Librarian, was inspired by the MPLA Leadership Institute at Ghost Ranch, NM, to get the ball rolling on the library technician certificate classes. These classes are a great benefit for any library staff member who hasn't had any formal training. Grant money can be applied for through the McMurry Library Endowment Fund and the Library Service Technology Act.

Endowment benefits libraries -- The Carol McMurry endowment has awarded \$82,924 to libraries and individuals around the state in 2002. It has awarded more than \$150,00 since its inception in 2000. The grant money can be used for competitive grants that allow libraries to buy children's books or adult books.

Raising Readers on Wyoming -Former First Lady Sherri
Geringer kicked off the Raising
Readers in Wyoming program recently at the Campbell County
Public Library in Gillette. The
Raising Readers in Wyoming program promotes reading to young
children between birth and five
years by giving them new books

as part of their regular well child visits. The goals of this program are to improve the child's health, encourage early literacy and support families as they prepare their children. This program is patterned after a successful program initiated in Maine.

Around the state -- Jeanette Woodward is the new Fremont County Library Director. After more than 20 years as director of college and university libraries in North Carolina, Virginia, Michigan and New Mexico, she switched to public libraries. She received her MLS from Rutgers. Woodward is the author of Countdown to a New Library: Managing the Building Project and is under contract to write Better than a Bookstore. She believes that libraries should imitate the bookstore approach to marketing and customer service while emphasing libraries' unique services. She plans to stay in the area while working on a new addition for Fremont County Library.

Natrona County Public Library has hired Laurie Spurling as the new Public Services Librarian. She comes from the University of Kansas Library where she worked five years. She has worked at public libraries in Denver and Las Vegas. Spurling earned her MLS from the University of Tennessee. In coming to the Natrona County Public Library, Spurling says she has come full circle. Her experience in academic and private libraries has been excellent experience for public library work.

Go Figure! Add up the numbers to equal a huge success -- An event five years in the making, and success greater than anyone anticipated.

Go Figure!, a charming interactive math and reading exhibit for kids recently ended its popular run at the Laramie County Library System.

Amy Shelley, manager of Youth and Outreach Services, applied for the grant in 1998. The application was one of only 75 accepted, and the only one in Wyoming. Then the wait began, since LCLS was one of the last library's on the tour.

In all, 4,744 people visited the exhibit during its run.
