President's Message

The MPLA Executive Board experienced a first this past month. We met for our board meeting via telephone conference call, acting upon a recommendation from the reorganization committee. MPLA Vice-President Wayne Hanway and I set up some ground rules in advance of the call to avoid confusion and interruptions. Reports that did not need discussion were submitted and accepted in advance of the meeting. Only items of business needing discussion were handled during the call. Overall, I have to say it was a very positive experience. We managed to conclude our business in just over two hours. Using a phone conference call in place of an in-person board meeting results in the following: 1) a significant savings in travel/hotel/meal cost for MPLA; 2) a cost savings for each member state. They do not have to pay for travel to and from the

board meeting for their representative and 3) a time savings for every board member. For each board meeting, board members arrive in Denver on the day prior to the meeting, stay overnight, attend the board meeting and return to the airport directly afterwards for the return flight. Two hours instead of two days is a significant savings! In the future, in-person board meetings will be limited to a conference meeting and one (or at most two) in-person meetings during the year, alternating with telephone conference calls.

I want to express my thanks to a few people who have been guiding forces as MPLA began to work on reorganization this past year. First of all, thanks to Donna Jones Morris for guiding the ad hoc committee who came up with the plan. Donna kept us on task and managed to get the work finished within a few months. Secondly, to Executive Secretary Judy Zelenski, who is doing an excellent job in tracking statistics for us (often before we even ask for them!) Finally, to our Steward Carol Hammond who is making sure we meet all our deadlines. There is still more work to be done but I think we are set to institute the necessary changes this April!

Carol Hammond Steward for Reorganization and Transition

Carol Hammond has held various positions within MPLA, including Arizona State Representative and President, but the assignment that has been unique is the one she now holds, that of the "Steward for Reorganization and Transition."

Carol appointed the Reorganization Task Force, which was identified as a needed step in the 2004 long range plan, during her term as President, and served with the task force as they developed the new model for MPLA. She accepted the assignment to see the reorganization implemented, and to plan the transition to the new structure. She has worked on the necessary bylaws revision, update of the Manual of Procedure, survey of interests for establishing the electronic communities, and other aspects of the reorganization over the past year. The project is anticipated to be completed this summer.

She brings to this task over 15 years of membership in MPLA and a record of leadership in the Arizona Library Association (AzLA) which awarded her their Distinguished Service Award in 1997. A graduate of Colorado State University, she has a MSLS from the University of Illinois Urbana-Champaign and a Master's degree in History from Gonzaga University. She has worked in public services in the libraries at UCLA, Gonzaga University (Spokane, Washington) and Arizona State University before taking the position as Director of the International Business Information Centre at Thunderbird, The Garvin School of International Management in Glendale, AZ. Carol has published in various library journals including College & Research Libraries, Research Strategies, and Reference Services Review and has also been a book reviewer for journals in the field of history.



Carol describes her current assignment in MPLA as "truly a labor of Love." She says MPLA has given her a wonderful network of colleagues and a talented group of people to work with, and her hope is that everyone in MPLA can find the connections and opportunities that she has to grow, be inspired, learn, and contribute. She will be serving as one of the mentors this year at MPLA's Leadership Institute at Ghost Ranch, NM.

Electronic Communities!

What is an Electronic Community?

In MPLA, these are interest groups which will have virtual spaces where members can ask each other questions, seek advice, look for best practices, new ideas, and benefit from professional exchange. Our longstanding "sections" that have represented different specializations and interests in the past will now be replaced with electronic communities. Each community will have a moderator who will help plan conference programs in this area, as well as organize and lead online discussion and exchange among the members.

How do these work?

Moderators of electronic communities may choose from some options of how to orga-

nize and conduct discussion and exchange among the members. They may announce a topic for discussion and a time frame for members of the community to join an online discussion, such as: The Reference Services Electronic Community is invited to join an online conversation on "Using instant messaging in reference" for three days, May 5-7, at our site on MemberClicks." Or : The Children's Services and School Libraries Electronic Community will discuss "New Ideas for Summer Reading," February 2-8, at our discussion site at Yahoo."

Moderators may also establish an open forum for members to post questions for the group, such as: "Does anyone use a vendor for cataloging foreign language materials, and can you share your experience and advice about this?" or "I am looking for a good source for how-to manuals for home and car repair in DVD format."

We are encouraging moderators to experiment with different sites and technology for engaging the community, as long as it is available to all and at no cost beyond the MPLA membership dues. MemberClicks provides some discussion features as does Yahoo and other sites. Whatever the program to be offered and wherever it is available, you will receive the information you will need to participate in an email.

What are the choices?

Many of you participated in our recent survey to determine


discussion topics, or volunteer to serve as a moderator.



Government is too big and too important to be left to the politicians. -- *Chester Bowles*

As I write this column, Congress is gearing up for a mid-term election in the Fall, the president is under fire for overreaching his authority, and the Supreme Court recently replaced two Justice vacancies. I don't know about you, but I think a refresher in 8th grade Social Studies/Civics is in order! In this issue I'd like to provide a general overview of the branches of government. In future issues I'll examine each branch more indepth.

Wary of the absolute power wielded by the British monarchy and smarting from the failure of the Articles of Confederation in coalescing a central government, the members of the Constitutional Convention created a government consisting of three separate branches, each with its own independent powers – making law, enforcing law, and interpreting law. The cornerstone of the United States Government is the Constitution, made public on September 17, 1787.

Article 1 defines the legislative branch and the powers of the Congress of the United States, which include minting money, declaring war, regulating commerce, and amending the Constitution. Article 2 defines the executive branch and the powers of the President of the United States. This article empowers the President to be Commander in Chief of the Armed Forces and to nominate ambassadors, Supreme Court Justices, federal judges, cabinet Secretaries and other Executive Department heads. Article 3 defines the judicial branch and vests power in "one supreme court" and lower courts that interpret whether laws violate the rights and liberties granted by the Constitution. While this system enjoys a "separation of powers" with each branch operating independently of the other, it also provides a system of "checks and balances" which prevent any one branch from wielding too much power. For example, while the President nominates Supreme Court Justices, the Senate votes to confirm them; and while only Congress can pass legislation, the President can block it with a veto, or the Supreme Court can declare it unconstitutional; and Congress can impeach the President.

Legislative Branch

U. S. Senate - <u>http://www.senate.gov/</u> - Find and contact your Senator, or find out the status of leg-islation and oversight in the Senate.

Executive Branch

President of the United States - <u>http://www.white-house.gov/</u> - The President is the focal point of our government, tasked with enforcing the laws of the land and being Commander in Chief of the military. He gets assistance from the Executive Branch, which includes the Vice President, Cabinet members, and independent agency directors.

Judicial Branch

Supreme Court of the United States - <u>http://www.</u> supremecourtus.gov/ - The most visible and powerful of the federal courts, responsible for ensuring "Equal Justice Under the Law", the Supreme Court has the final decision about the meaning of laws, how they are applied, and whether they violate or uphold the Constitution.



Applications Now Being Accepted for MPLA 2006 Leadership Institute

Excitement is building about the 2006 MPLA Leadership Institute! The institute will again be held at Ghost Ranch Education & Retreat Center near Abiquiu in northern New Mexico. This will be the fifth leadership institute sponsored by MPLA. We are pleased to have SirsiDynix as this year's funding partner for the institute to be held Sunday, October 29 through Friday morning, November 3. Thirty attendees, four mentors from the MPLA membership, institute facilitator Maureen Sullivan, and coordinator Mary Bushing will attend the institute in the fall.

The five criteria for applicants to this year's institute were approved by the MPLA Board at the suggestion of the Leadership Committee. This year's criteria are:

(1) Current membership in one of MPLA's affiliated state library associations

(2) Employment in a library within the 12-state MPLA region

(3) MLS or equivalent master's degree relevant to the library field



(4) 2 to 12 years post-master's work in a library-related job (prior to the institute)

(5) A record of experience that demonstrates leadership potential

The application form is available on the MPLA leadership web page www.mpla.us/leadership/index.html. The deadline for email application files (MS Word) to Institute Coordinator, Mary Bushing, is midnight CDT on Sunday, May 14. Following the deadline, eligible applicants will be evaluated by their state committee (the state MPLA representative, the president of the state library association and sometimes the state librarian). The state committees forward their recommendations to the coordinator and the MPLA Leadership Committee. It is not unusual for three times as many applicants to apply as there are attendee slots in the program. All applicants will be notified by August 1 of their status.

The costs for the institute are kept extremely low through the generosity of vendor partners and MPLA who together underwrite almost two-thirds of the expenses for the weeklong professional development event. Individuals selected to attend must only secure funding to cover their transportation and their registration fee. The registration fee is \$450 for librarians who are current members. of MPLA and have been for at least two years. Non-MPLA members pay a registration fee of \$550. The fee covers room and board for five and a half days, morning and afternoon snacks, all the bottled water one can drink (and everyone drinks a lot of water given the altitude and the high desert air), institute learning materials including a large notebook of articles and other supporting items, and the fabulous expertise of Maureen Sullivan, a nationally recognized trainer and consultant on leadership and organizational

development in libraries of all types. Attendees will be engaged fully throughout the institute and their retreat from the world is made even more complete by the remote location where cell phones do not work, there are no televisions, and email access is almost totally non-existent.

In the past, many libraries have been quick to recognize the tremendous professional development opportunity granted to their employees and have provided funding for attendance. Most of the MPLA state library associations also provide financial support for those selected to attend. In addition, individuals have sought grants from MPLA or other sources to assist with their attendance costs. In the first four vears, there have been more than a few individuals who have paid all of their expenses themselves recognizing the expense as a career investment and therefore worth it. Registration fees are not due until late September thus giving selected applicants time to arrange a funding package that meets their needs.

The mentors for 2006 are being selected at this time and will be announced later in the

spring. Mentors are generally selected to represent a wide range of library types and all mentors have had both administrative and leadership positions during the course of their careers. Mentors typically have reputations as individuals who freely give of their time as formal and informal mentors, assisting others within the library workplace and the profession with career struggles and planning as well as the day-to-day challenges of library work and organizational culture.

Unlike some leadership institutes, MPLA does not assign mentors to attendees but

rather creates an environment and schedules opportunities for attendees to meet with mentors one-on-one or in small groups as their needs and inclinations inspire them. Additionally, attendees select learning partners from among their peers and these individuals serve as peer mentors and sounding boards both during and after the institute. Mentors and attendees alike serve as role models for one another.

We want the very best in the West to be part of this wonderful initiative. We can already point to dozens of institute alumni or "fellows" as we like to call them, who have quickly moved into more responsible positions within their own libraries, other libraries, state or regional associations, and even national professional associations. While we have resisted the temptation to put a brand or tattoo on the forehead of each fellow, you can still tell who they are: they are happy to be librarians, they recognize their own worth and potential, and they are moving and shaking the MPLA library world!

AskColorado, the 24/7 online reference service provided by Colorado libraries, has joined forces with a new, real-time online service that is part of the state of Colorado web site. Live Help is available on the state web site, <u>www.</u> <u>colorado.gov</u>, by clicking on the "Live Help" icon to reach a member of the Colorado.gov customer service staff or a librarian through AskColorado. Live Help is available on the state website, <u>www.</u> <u>colorado.gov</u>, 24 hours a day, seven days a week, except on major holidays. The Live Help service is delivered through a collaboration between Colorado.gov, Ask Colorado, and the Statewide Internet Portal Authority, which was formed in 2004 to oversee the success of Colorado.gov. Ask Colorado is a collaborative effort of 61 libraries from around the state.

Staff at the University of Northern Colorado Michener Library recently undertook a quilt project as a service activity. About 20 people including faculty and classified staff contributed money, time, materials and enthusiasm to the cutting and piecing that occurred February 23. People brought sewing machines, irons, and ironing boards into Michener Library's processing area, which was converted into a sweatshop of sorts for the evening. The pieces needed for the top were created. A talented faculty member will do the final steps of assembly and quilting. Montana

Montana's 2006 Centennial Library Conference May 3 –5 in Missoula will feature pre-conference workshops with educator, Bill Moen on "21st Century Library Cataloging" which will be co-sponsored by MPLA. Other pre-conferences feature librarian, author, and web expert, Rachel Singer Gordon on "The Accidental Library Manager", and Montana's own Jan Fandrich on "Funny Bones for Customer Service."

The Summer Institute for Library Directors will be June 19-22 at the MSU campus in Bozeman. Sponsored by the Gates Foundation its title is "Keeping Your Patrons Connected." The workshop, part of the Gates Rural Library Sustainability Program, is designed to help small and rural libraries create and implement technology sustainability action plans.

Three tribal college libraries are added to the Federal Depository Library Program (FDLP). Little Priest Tribal College in Nebraska, Fort Peck Community College and Salish Kootenai College in Montana join the more than 1,250 Federal depositories nationwide. They are the first Native American libraries to join the FDLP.

Kalispell Regional Library Medical Center Library received a \$2000 Planning Award the Pacific Northwest Region/National Network of Libraries of Medicine. Part of the award is for a survey of consumer health information services which will assess Montanans' access to consumer health information through libraries. Montana's Networking Task Force has secured the Testing and Education Reference Center for subscribers of the statewide contract-provided Gale/InfoTrac full-text databases. The TERC combines Peterson's college search references with interactive educational and vocational test preparation instruments. It includes information about graduate and undergraduate degrees and vocational and 2-year degrees. The higher education school database is searchable by location, major, tuition, sports and more. It also includes interactive online practice tests (22 education-related, 23 career-related tests). Some e-books are included.

Nebraska

University of Nebraska, Omaha. Regents of

the University of Nebraska approved Alley Poyner Architecture to provide architectural and engineering design services for Phase I of the library building project on the Omaha campus. Phase I is the expansion component of the project, a 31,500 square foot addition. Ground was broken on August 8, 2005, and construction is presently

Commission will award scholarships of \$1,000 for students working at the bachelor's or the associate level and \$2,500 each year for students working on master's degrees



The Oklahoma Council of Academic Library Directors is sponsoring a workshop on the ACRL Standards for Libraries in Higher Education (2004) on April 27, in Edmond, Oklahoma. Speakers are Dr. Bill Nelson and Dr. Bob Fernekes, who are also facilitators for the ACRL preconferences at ALA. The workshop will be geared to the Higher Learning Commission of North Central Association of Colleges and Schools accreditation. For more information: 405-736-0259. Lee B. Brawner, longtime executive director of the Metropolitan Library System in the Oklahoma City region, passed away in February A memorial service was held on February 12. In lieu of flowers the family requested that donations be made to the OLA Endowment Trust or to the Freedom to Read Foundation. Lee Brawner was a major voice in Oklahoma libraries and an active leader in the Oklahoma Library Association for over 30 years. He will be greatly missed by his friends and colleagues.

South Dakota

The 2006 South Dakota Legislative Reception was held January. 18 at the State Library in Pierre where librarians and legislators discussed Bills promoted by SDLA. South Dakota librarians attended both House and Senate Sessions and were introduced to the Legislators. Legislators received reception invitations and a brochure describing SDLA.

State Library Planning and Evaluation. Consultant Mary Bushing has been hired to lead the South Dakota State Library through this process. During Phase 1, telephone interviews were conducted. Phase 2 was launched in February 2006 with a series of focus groups held around the state. Community leaders, library representatives, and members of local communities were invited to participate in these discussions. It provides an opportunity to gather opinions and suggestions for what kind of library services people think need to be provided by the South Dakota State Library.

Family Time, Prime Time Reading Time Programs. The South Dakota Humanities Council and four libraries received a Prime Time Grant which will provide a 6-week reading program for children and their families. The program helps to establish the habit of reading for parents and their children. Themes which will be discussed include sharing, fairness, courage and honesty. Sites are the Yankton Community Library, the Huron Public Library, Sinte Gleske University Library on the Rosebud Reservation, and the Oglala Lakota College Library on the Pine Ridge Reservation. The Prime Time Program was developed in 1991 by the Louisiana Endowment for the Humanities and has spread to more than 500 sites in 36 states. Nine states applied to host the 2006 program. Five were selected – South Dakota, California, Georgia, Kansas, and Ohio.

SDLA will hold two Spring Forums for library staffs in April, one in the eastern part of the state and one for the western. Topics include Disaster Planning, Distance Learning, Book Repair, and Marketing Your Library.

Jump Start Workshops were held in January at various libraries throughout the state. Jasmine Rousey, State Library Children's & Youth Services Coordinator, led the workshops to introduce Children's Librarians to the 2006 Summer Reading Program theme, "Paws, Claws, Scales, and Tales." Suggestions for all aspects of Summer Reading Program activities were shared by participants.

Utah

The Utah Legislature is considering two important library-related bills: HB 41 would mandate that the Utah State Library "preserve, conserve, catalog and make available all Utah government documents in a digital format" HB 251 would provide an increase for on-going support to public libraries in the form of library development grants. Both bills enjoy strong support .

The Utah Library Association is hosting an ALA Library Administration and Management Association (LAMA) regional institute on "Col-

laborating, Partnering, Co-operating: The Good, the Bad, and the Future. The institute will be held May 19, in St. George.

Shannon Hale, a resident of Salt Lake City Utah and recent graduate of the University of Utah, was awarded a Newbery Honor medal which will be presented to her at the ALA annual conference in New Orleans this summer. Ms. Hale is tentatively scheduled to appear at the Utah Library Association's annual conference in May 2006 in St. George, Utah.

Utah's online library, Pioneer is currently celebrating its tenth birthday.

Fines for New Orleans @ Natrona County Public Library. Natrona County Public Library was full of festivity, fun and fundraising this February! Through joining the Adopt-A-Library program in October 2005, NCPL partnered with 20 other libraries to help New Orleans Public Library rebuild. Mardi Gras decorations adorned the library and patrons received beads when they paid their fines or made a donation on each Tuesday in February. NCPL combined fine money with grants from the NCPL Foundation and Friends to make a substantial contribution to rebuilding efforts. The fundraising culminated with a Fat Tuesday Celebration on the final day of Mardi Gras. Highlights included live music performed by Ju Ju Jazz and King Cake for all.
