## **Redesigning the MPLA Website**

As MPLA Webmaster, I deal with a variety of issues in managing and administering the MPLA website. Most of the issues are routine, automatic. I update the website as needed, but there aren't a ton of changes to be implemented most of the time. The exception to that generalization is when new executive officers take over and appoint committees. So, as webmaster, I busy myself most of the time with finding something to fix on the website, or seeing if I can make something work better or look better. And every now and then, when I'm really tired of looking at the website's design and style, I go into "web designer mode" and play around with colors, images, style elements on the website. If anyone has ever done web design, you know every now and then you like to shake things up and change things. My problem invariably is I choose a bad time to redesign the website. My "day job" is Social Sciences Librarian (psychology subject specialist) for the Edmon Low Library at Oklahoma State University, and that keeps me pretty busy. This past spring, I started to get the urge to redesign the MPLA website.

For those who perhaps didn't know – MPLA adopted a new logo a year or two ago, a logo which replaced the old "MPLA globe." As Webmaster, I plastered that logo all over the website – it was our brand. But I kind of got the urge to tweak the style and make the website look a little sleeker and less cluttered. As you might have noticed (or not noticed, as the case may be) the website still looks exactly the same as it always has. Trust me, I know, I'm working on it as fast as I can <sup>©</sup>

When I redesigned the website a couple of years ago with the new logo, my plan was to do a two phase implementation, as there were some things I needed to do behind the scenes before I could consider the task complete. In the meantime, I got tired with the new look, and started playing around with the design again, putting aside the behind the scenes things I needed to work on.

If anyone has ever done web design, you know every now and then you like to shake things up and change things.

As webmaster, I've never been shy about admitting that I know relatively little about creating and manipulating graphics. In fact, I know just enough about creating them to make what I do create look really really bad. So, when I took this notion to redesign the MPLA website with a sleeker banner image, it would only happen if I forced myself to learn Adobe Illustrator. So, I started playing around with the banner image.

Eventually, this is what I came up with:

I liked the sleek design, it was crisp and clean (and no caffeine.) My thinking on it was the M in MPLA represents the mountains and the plains – the M is the mountains, while the horizontal line represents the plains. My initial thoughts on the M to represent mountains and plains called for the M to be colored grey and the plains line to be tan. After looking at the design it was pretty ugly. So, I had to make it one color. What colors did I consider, you ask? Just about all of them, with the big consideration being what color or colors would look best at the size and screen resolution I was creating to. I kind of picked purple because it wasn't blue or red (which

were colors we hadn't used on the website before.) As Judy can attest to, when I was designing the banner, I was shooting emails to her, sometimes by the hour, asking her opinion on samples (thank you for putting up with that, Judy!) Eventually we came to the design above. However, there was a new issue -- the new banner for the website did not incorporate or make use of the MPLA logo, which looks like this:



My solution? Put the MPLA logo elsewhere. Here is a little preview of what the new MPLA homepage will look like:



Part of the reason why you have not seen the redesign of the MPLA website is because I was working to solve the issues behind the scenes, which I mentioned earlier. That issue is largely the use of tables on to layout information. Use of tables in HTML is common practice, but not particularly good code. We have ways to lay out information on web pages using cascading style sheets, which we already use on the MPLA website. The problem is the CSS layout elements are pretty alien to me – I'm speaking of float. This has necessitated vast hours of trial and error and trail and error. That was how I spent my summer vacation, and I still have not completed the task yet but we're getting there. Further complicating the issue is the coming of the Electronic Community Portal, and the need to make both parts look like each other. So, I've been working with Community Portal Administrator Roy Degler to make sure there are design elements in common between the two sites.

One of the things I did this summer was to look at the MPLA logo and see if we can tweak it to make it visually more different. I had thought it might be kind of cool to "google-ize" the logo to reflect the seasons across the MPLA region. For example, in the spring, we might place some flowers coming up in front of the mpla, while in the summer, we might have the sun shining brightly, while in the fall, we have leaves blowing across the logo, and in the winter, we see snow falling behind the mpla.

As I mentioned, I have little skill with graphics, so this was far and away beyond my limited capabilities. So, I enlisted the assistance of a talented colleague of mine here in the OSU Library. Kate Blalack is a recent MLS graduate and works in our Special Collections and University Archives department. I asked Kate to "play around" with the MPLA logo to see how we might spice it up a little. She spent some time in PhotoShop, playing around with our logo, and I thought I would share a couple of the ideas she had – one is pretty similar to what we currently use with the addition of some flares in the mpla. The other idea is a more muted color scheme, with some purple in keeping with the banner color scheme.



This remains an ongoing project, one I hope is completed sooner rather than later. But as anyone in school or academic libraries knows, once school starts all free time seems to evaporate. I wanted to share some of our website plans with you, and give you a little insight in the process. # Around the Region

## Arizona

Jana Bradley, Director of the School of Information Resources & Library Science at the University of Arizona, has announced that in June 2009 she will step down as director and join the faculty.

The **Mesa School District** made a final decision to go ahead with their original plans to eliminate all school librarians, nurses and speech pathologists in the district. Library Media Specialists will be sent back to the classroom. The Phoenix area district has 87 schools and serves 74,000 students. School librarians protested the initial decision in April and the school district had agreed at that time to re-visit the issue.

# Colorado

"Town hall" meetings focused on Colorado's libraries, with eleven communities in Colorado participating during July and August. Representatives of the three major library organizations in the state - Gene Hainer from the Colorado State Library, Valerie Horton of the Colorado Library Consortium, and Martin Garner, President of Colorado Association of Libraries - were the principal speakers. They shared information on how these organizations support the work of libraries. Also discussed were the future of libraries in Colorado and the future of the library profession. The meetings were attended by library staff as well as library board members and patrons. Discussion ranged from what libraries are currently doing well to what can be improved.

The **Colorado Association of Libraries** is developing a Leadership Institute which will kick off at the 2008 CAL Conference and will continue as a yearlong program including both face-to-face and virtual sessions. The vision is to develop outstanding leaders within CAL and the Colorado library community. The mission is to create a culture of leadership at CAL by engaging its members in leadership development activities including self-assessment, networking, and skills development.

BCR has been selected to serve as intermediary to administer and manage the Bill & Melinda Gates Foundation Opportunity Online grants in three states, partnering with the BCR member state library agencies of Alaska, Oregon and Washington. The grant program will help eligible public libraries in each of these states upgrade computer hardware in communities with high concentrations of poverty.



During a recent visit to her daughter's home in Salt Lake City, MPLA Colorado Representative Mary Katherine Katzer took her grandchildren to the Sprague Branch of the Salt Lake City Public Library System, which is in their neighborhood. Here they are at the front door – Kylee is three and Bryson is 16 months old. Because of Labor Day, the library was closed. Mary Katherine says she'll plan better the next time she goes to visit.

## Kansas

The Dorothy Bramlage Public Library received a grant sponsored by Frontline/World and the American Library Association to host the Social Entrepreneurs Film Program in Junction City. The program is a grant opportunity that supports the screening and discussion of a selected short documentary film based on social entrepreneurship efforts around the world plus a related program. The program seeks to connect communities to the concept of social entrepreneurship and to promote dialogue on a local level. Funding for the Social Entrepreneurs program is provided through a grant from the PBS and the Skoll Foundations. The awards include a grant to support promotion and program expenses, copies of a DVD containing the entire 16-part Frontline/World Social Entrepreneurs Film Series compilation, and supporting materials including bookmarks for distribution to patrons and participants. MPLA member and Kansas Representative Susan Moyer is Library Director.



The **Kansas State Library** took its 2008 Road Show to seven locations in August and September. Presentations included new information about library standards, HomeworkKansas, Talking Books, Web-Junction, new databases, and more. Attendees also received five contact hours in the Library Certification Program for Public Library Administrators.

The Marshall Cavendish Award for Excellence in Library Programming was presented to the **Johnson County Library** at the ALA Annual Conference in Anaheim in recognition of its *Literature in the Justice System* programming for juveniles and adults. Deputy Director **Tricia Suellentrop** and Youth Outreach Librarian **Kathy McLellan** developed the Read to Succeed program at the Johnson County Juvenile Detention Center and Changing Lives Through Literature alternative sentencing program for teens in 1998-1999, and Outreach Services Coordinator **C.J. Sullivan** created the Stories about Women program with her Adult Corrections counterpart in 2005.

Aurelia Jackson is the new cataloger for the Northwest Kansas Library System. Coming from work in a variety of school settings, she received her MLS in Library Media K-12 from Forth Hays State University.

The **Kansas State Library** is presenting its second Statewide Training for Trustee Certification in October. MPLA members **Mary Bushing** and **Laura DeBaun** are presenters for the two workshops which will qualify a trustee to hold a three-year certificate.

# Montana

**Bozeman Public Library** hosted the first Children's Festival of the Book in August, featuring Caldecott Medal winner Paul O. Zelinsky as key note speaker. Other activities included readings by authors Nora Martin and Ben Mikaelson, a puppet show and



The **Montana State Library** held its annual Fall Workshop in Livingston September 19–20 with a wide variety of workshops. To help libraries offset rising gas prices, the State Library paid for the night's lodging, allowing participants to attend both days without having to travel twice. For new library directors, the State paid all travel expenses and included a special session for them.

Spanish Language Outreach (SLO) grants totaling \$4,200 have been awarded to public libraries in Belgrade, Billings, Bozeman, Dillon, Helena, Kalispell, Missoula and Stevensville. The libraries will use the grants, ranging from \$250 to \$785, for activities, programming, and materials for Spanish speakers in their communities. Also, the "Spanish Language Outreach in Montana Libraries" blog is up and running (*mtslo. blogspot.com*) – a great place where librarians can share their ideas and resources for SLO activities. Montana's SLO trainers, **Molly Kliss** and **Kathy Robins** will use this to post updates and special features.

# Nebraska

Linda Rea, Director of the Hastings Public Library, MPLA member since 1971, and a past president of MPLA, is retiring in October. Her plans include home organizing and travel.

Nebraska held its second **Future Search Confer**ence in June. According to MPLA member **Kathy Tooker**, Eastern Library System administrator, the purpose of the Future Search Conference was to bring people together with the intention of bringing a fresh perspective to Nebraska library service needs and fostering direction, partnerships and collaboration. Eighty people attended including four high school students, city administrators, a banker, an architect, attorney and a person from a social service agency. Funding for the conference was provided by Nebraska Library Commission, Peter Kiewit Foundation, Regional Library Systems, and the University of Nebraska at Omaha. He has also worked at the University of New Mexico Libraries as the director of administrative services, the director of the Fine Arts Library and the director of Zimmerman Library.

# North Dakota

Voters in Cando have united in support of their public library, with over 75% of Cando residents voting in favor of a measure to allow the city to levy a property tax of eight additional mills to help support the library. Without this support, the **Cando Community Library** would have closed down.

The Divide County Library is now home to the Divide County technology Center. A day after the Divide County Jobs Development authority decided to close the technology center, plans were made to move some of those services to the public library after a meeting between JDA President, Doug Graupe, and Divide County Librarian, Leslie Deering. The arrangement will provide four more computers to the Divide County Library and still maintain the same internet services that the Job Development Authority provided in their technology center. Not only will job seekers in Divide County have a place to go and use a computer to write a resume, search for a job online, or check e-mail, but the Divide County Library can also expect some residents to "discover" all the services offered by the Divide County Library.

Library Services on the **Turtle Mountain Reservation** will expand to serve the residents of the Turtle Mountain Retirement Home. Services include a "portable" library which will include large print books and magazines, audiobooks, and videos for use by residents at the home. Materials will be kept onsite and new materials will be brought in weekly from the **Turtle Mountain Community College**. Residents of Turtle Mountain Retirement Home can also sign up for a library card through Turtle Mountain Community College. The service is being funded by a grant from the Institute of Museum and Library Services.

The North Dakota State Library once again staffed a booth at the 2008 North Dakota State Fair in Minot, July 18-26. The promotional booth highlighted the Online Library Resources, Disability Services, and library services in general. State Library staff had the opportunity to interact with thousands of fair goers and promote not only the services offered by the North Dakota State Library, but also encouraged people to use the library services provided to them by their local libraries. Many people who stopped by the booth expressed an interest in the Online Library Resources, especially the EBSCO Auto Repair Reference Center which was a huge hit with fair goers. Many people passing by the booth paid compliments to the quality of service that they receive from their local libraries and the State Library. Quite a few people were aware of the Talking Books program and commented on how it have made a positive impact on someone they knew who used those services.



"Staffing a booth of this magnitude," says MPLA Representative Al Peterson," is quite an undertaking, but the end results justify the work required for having a booth at the North Dakota State Fair."

The State Bank of Lakota donated \$500 to the **Lakota City Library** for their reading program. For twenty eight years, the State Bank of Lakota has donated money to the library for the purchase of reading materials, book bags, and free books for a drawing used as incentives for reading programs.

The **North Dakota Library Association** is sponsoring its First Annual Innovative Book Cart Competition at NDLA 2008. Invitations are extended to send

## Oklahoma

The second of three IMLS grant-funded Information Matrix Camps was held in July at Rose State College. Twenty-nine middle school students attended and had an opportunity to visit many different libraries including the downtown Oklahoma City Public Library, the Memorial Institute for the Prevention of Terrorism library at the Oklahoma City Bombing Memorial, the Oklahoma Department of Libraries, the Oklahoma Library for the Blind, the University of Oklahoma Libraries, the corporate record-keeping division of Devon Energy, and the library at Integris Baptist Hospital. Seven campers returned for a second year and participated in activities such as job shadowing at the Moore Public Library and visiting several law libraries. The camp is co-sponsored by the Oklahoma Library Association's Career Recruitment and Retention Committee and Rose State College. The hope is that many of the participants will consider entering the library profession in the future.

## South Dakota

The South Dakota State Library announced several new additions to their staff. Jane grew up East River and has teaching and library experience in East River schools. She is back in Sioux Falls after working for many years at Mesa State College Library in Colorado. MPLA member Julie Erickson, who has been covering the entire state, will remain as Electronic Resources Coordinator, specializing in electronic resources training at West River locations. Two new School Library Coordinators have also been added to the State Library staff. MPLA member Joan Upell, formerly of Tiospaye Topa School Library, and Lee Crary, formerly of Bison School Library, will

work with schools around the state to ensure that quality library information literacy skills and resources are an integral part of the educational process. The goal of the new program is to build excellent school libraries in every school district in South Dakota.

All functions of SDLN are funded solely by member libraries cooperating to share resources among school, public, private, academic, tribal, medical, government and corporate libraries.

include guidelines for depositing electronic format copies with the State Library, the Library of Congress and other designated state publications depositories, and 2) the ability to

# Utah

Elizabeth Elder was introduced as the new Salt Lake City Library Director at the recent joint ULA-MPLA conference. She was featured in a very favorable *Deseret News* article about her stint at the library. Elizabeth was quoted as mentioning that she wants the city residents to feel that the library "belongs" to them, and that she is positively impressed with the city residents. Elizabeth is thrilled that many Salt Lake City residents visit the library often feel. She mentioned that a new library branch may be constructed soon, increasing the number of branches to six. Utah State offices are currently open four days weekly as part of the *Working 4 Utab* program established by Governor John Huntsman. As part of this program, the **Utah State Library** hours are Monday-Thursday 7 a.m. – 6 p.m. The program began August 4 and is scheduled to last at least 4



and is scheduled to last at least one year.

A nationally published article distributed by the Gannett News Service declared that library visits have increased around 10% and listed Utah and Wyoming as states leading the list of increased library visits.

The **Utah Library Association** Continuing Education Committee sponsored a Fall Workshop September 19 at the College of Eastern Utah in Price. It included programs on *The Utah Kids Ready to Read!* Program, Young Adult Services, Reference Services, Utah Pioneer Online Library, Health & Wellness issues, and Marketing Library Services and Establishing Community Partnerships.

The Utah Library Association Childrens and Young Adult Round Tables co-sponsored a successful summer program. The Summer Workshop in Cedar City was held August 14-15. Speakers included Fred Adams of the Cedar City Shakespeare Festival and author Jessica Day George.

# Wyoming

The **Natrona County Public Library** has been chosen as one of 13 grant recipients nationwide to participate in *Smart Investing @ your library*<sup>®</sup>, sponsored by ALA's Reference and User Services Association



and the FINRA Investor Education Foundation. NCPL is holding a 4-part investor

education series in September and October, directed at young families and individuals, with all participants welcome. Topics include basic financial planning, stocks, bonds & mutual funds, investing for retirement, estate planning, and money & happiness. A special feature of NCPL's program is its focus on all age groups. Programs about spending, saving, and credit cards will be provided for children, tweens (grades 4-6) and teens. A special seminar will be held for seniors and retirees as well, covering the unique challenges and investing strategies seniors and those nearing retirement can learn from. Numerous resources have been added to the library's collection as well, including online resources to assist patrons as they learn about financial planning and investment.

As part of the **Wyoming Newspaper Project**, Wyoming State Librarian **Lesley Boughton** and Digital Initiatives Librarian **Erin Kinney** trained nearly 50 people in Cokeville for metadata work. They also gave presentations at the Cokeville Town Hall, Green River, Afton and Kemmerer in August.

The final deadline to submit individual grant requests this year is December 3, 2008. Eligibility requirements:

• Resident of a state in the MPLA region

• Membership in MPLA (for mini grants of \$150 or less the applicant must be a current member of MPLA and must have been a member for the past full calendar year; for regular grants up to \$600 applicant must have been a member for the past two calendar years - total of three consecutive years.

• Currently employed in a library, be a student accepted in an advance degree program in library science or a related discipline, or hold a position or office associated with a library such as a trustee. Grant funding will generally not be awarded to a student unless that student was previously employed in a library or related position in the MPLA region and intends to pursue his or her library career in the MPLA region.

• A past recipient of a professional development grant may not apply for another grant until three years have elapsed following the end of the calendar year in which the previous grant was approved.

Grants are awarded to support the following:

• Attendance as a participant or a presenter at a library or scholarly workshop, seminar, or conference, including the MPLA annual conference.

• Visits to another library to receive or provide significant advanced training in library services or procedures.

• Library related research projects.

• Formal course work leading to an advanced degree in library science or a related discipline.

• Formal course work not leading to an advanced degree but directly related to an individual's library position.
