OLA/MPLA Joint Conference Keynote Speaker

Dr. J. Rufus Fears will be the keynote speaker for the OLA/MPLA Conference April 19-21, 2010 in Oklahoma City. Dr. Fears is David Ross Boyd Professor of Classics at the University of Oklahoma, where he holds the G. T. and Libby Blankenship Chair in the History of Liberty. He also serves as David and Ann Brown Distinguished Fellow of the Oklahoma Council of Public Affairs. He earned his Ph.D. from Harvard University. Before joining the faculty at the University of Oklahoma, Professor Fears was Professor of History and Distinguished Faculty Research Lecturer at Indiana University, and Professor

of Classical Studies and Chair of the Department of Classical Studies at Boston University.

An acclaimed teacher and scholar with 25 awards for teaching excellence, Professor Fears was chosen Professor of the Year on three occasions by students at the University of Oklahoma. His other accolades include the Medal for Excellence in College and University Teaching from

Potpourri of Conference Information

The theme: Explore the Possibilities

ALA President and MPLA member Camila Alire will be a featured presenter at the conference. On Monday, she will present a pre-conference workshop on Frontline Staff Advocacy. On Tuesday, she will be the speaker for the Legislative Luncheon, will present an afternoon program on "Serving Your Latina Communities: Whose Responsibility Is It and Why?", and then will speak at the ALA Forum.

The MPLA Executive Board meeting will be Sunday, April 18th, starting at 3:00 p.m., and will be followed by a dine-around. With a plethora of restaurants, bars, night clubs, and other entertainment just a short walk away from the conference hotels in Bricktown, it will be a great way to start the conference.

There will be a full slate of pre-conference workshops on Monday, April 19th.

The banquet Monday night will be an awards banquet, plus a featured speaker.

Special MPLA events will include the Hot Tub Round Table (planned for after the banquet on Monday night), the pub crawl in Bricktown (time not yet determined, but probably either Sunday night or Tuesday or possibly both), the Leadership Institute alumni reunion (Monday before the banquet), the MPLA President's reception (Tuesday night in the President's suite), and the MPLA Business Meeting (Wednesday morning at 8:45.) Roundtables will have several chances to meet, but most scheduled ones will be first thing in the morning.

The All-Conference Event on Tuesday night will be very special. Oklahoma City's recently constructed

downtown library will be closed to the public that night so that conference attendees can enjoy refreshments, top-notch piano music by Wayne McEvilly, and a special event where costumes made from library materials will be paraded on a runway and judged, with rough-riding and fun-loving Oklahoma author Michael Wallis as the emcee. There should be lots of entertainment in this. After all, library materials are not commonly considered to be wearing apparel, and it will take both imagination and humor to come up with outfits that work and stand a chance of winning one of the prizes. More information about this will be forthcoming as the ACE planners work on it, but take note that MPLA members are strongly encouraged to get in on the fun. Start planning your costumes now! Working in teams would be a good idea, too.

The annual Oklahoma Book Awards ceremony will be Saturday night, April 17th, at the Edward L. Gaylord - Boone Pickens Oklahoma Heritage Center, and MPLA members are invited to attend. But tickets cost at least fifty dollars and must be purchased in advance. Contact Wayne Hanway or the Oklahoma Center for the Book for more details.

The conference runs through Wednesday, April 21st, and there will be a full slate of programs scheduled right up till 3:30 p.m., so try to schedule your departure after that time. And with Bricktown next door, staying over Wednesday night and leaving in the morning is definitely a smart idea.

The conference web site will make its appearance soon, with hotel reservation information, information about traveling to and around Oklahoma City, conference information, and lots of stuff about things to do. Online registration will be available via the web site at a later date.

2010 MPLA Awards

Do you know someone in the library world who goes above and beyond to provide service well above the level of their job description, someone who has innovative ideas, new approaches to old problems, a level of enthusiasm and positive thinking that affects both librarians and patrons? Is there a special project in your community that libraries and librarians have been a part of, perhaps one that has not been recognized in other ways? Or perhaps you know someone who has given years of service to school or public libraries, or who has made a significant contribution to the profession over a period of years. Please consider nominating such a person, organization, or company for an MPLA award.

Awards will be presented at the 2010 MPLA Joint Conference with the Oklahoma Library Association in Oklahoma City, Oklahoma, in April 2010. Academic, public, and school librarians are eligible; groups, organizations or companies will also be considered for appropriate awards. Nominees for some of the awards must be MPLA members. The MPLA Literary Contribution Award will be given to an author whose work has furthered an understanding and appreciation of the twelve-state Mountain Plains region.

Nominations must be made by a current member of MPLA. To nominate a person or group for any of the five awards, please use the nomination form on next page, or find it on the website, <u>http://www.mpla.us/com-mittees/awards/index.html</u>. Nominations must be postmarked by the deadline, January 15, 2010 and may be sent by mail or by email.

The MPLA Awards Committee is seeking nominees for the following five awards:

• *MPLA Beginning Professional Award*: To recognize an MPLA member who, within the first five years after receiving a library/media masters degree, has made a positive impact as a library media specialist on the quality of library service in his/her library or community. Innovative programming and planning, use of resources, and the implementation of special projects will be considered.

• *MPLA Distinguished Service Award:* To be given to an MPLA member who has made notable contributions to the library profession or has furthered significant development of state, academic, public, or school libraries in the Mountain Plains region, or who has performed exemplary service for an extended period of time. If a retired individual is nominated, the nominee may be a past member of MPLA.

• *MPLA Unsung Hero Award:* To be given to any library individual(s) or group(s) in the MPLA region who have worked on a special project that has significance to a community but which has not been eligible for a library award, or which, for other reasons specified by the nominator, has not been recognized by any library organization to the degree that it merits.

• *Carl Gaumer Library Champion Award:* To be given to the individual, organization, or company whose positive support of the Mountain Plains Library Association is demonstrated through repeated conscientious endeavors in support of libraries, library staff, and trustees, or through professional activities.

• *MPLA Literary Contribution Award:* To be given to an author whose published writings have successfully furthered an understanding and appreciation of the Mountain Plains region. The author need not reside in the region, and the nomination may be based on either a single work or a body of works. Published works will be evaluated on the basis of literary worth, readability, and evidence of responsible research.

Around the Region

ARIZONA

Appaloosa Library, Scottsdale's newest branch, opened November 4, 2009. The 21,500 sq. foot library was designed to merit a LEED Gold rating with the U.S. Green Building Council and features over 80,000 items, 92 public computers and computer lab , free WIFI, an interactive early literacy children's area, dedicated teen space, and a drive-through service window.



Arizona commemorates 100 years of Statehood on February 14, 2012, being the last of the contiguous 48 states admitted to the Union, Two statewide efforts have been designated Arizona Legacy Projects: The Arizona Memory Project and the OneBookAZ. The ASU Public History Program and Coordinating Committee for History in Arizona are gathering this information in support of the Arizona Historical Advisory Commission and its work in commemorating the Arizona Centennial. Arizona State Library, Archives & Public Records - Arizona Tribal Librarians 7th Gathering: Confronting 21st Century Social & Safety Issues was held November 6th. The Gathering focussed on the issue of safety in tribal libraries during turbulent times. Topics include addressing dropouts, gangs, and library policies.

The Special Collections at the **University** of Arizona Libraries is hosting an exhibit and lecture series examining the origins of early writing and literacy. Writings Out of Time: The University of Arizona's Cuneiform Collection, on display until Dec. 8, 2009, is an archaeological exhibit showcasing the Arizona State Museum's extraordinary holdings in Near Eastern antiquities.

The Arizona State University Libraries is looking for ASU undergraduate and graduate students who are book collectors to participate in an annual Student Book Collecting Contest which will run through February 18, 2010. Undergraduate and graduate student winners of the contest receive cash prizes, with the top prize in each category being \$600.

BCR and the Library and Information Technology Association (LITA), a division of the American Library Association (ALA), have agreed to develop a reciprocal continuing education program to complement and expand the training opportunities for the members of both organizations. This service is being sponsored by the Colorado State Library and by CLiC (Colorado Library Consortium.)

A new feature to the **Colorado Association of Libraries** Conference in November is the "Technology Petting Zoo" where latest trends in online resources and software are introduced. In addition, economics and fundraising are the featured topics in many of the programs and workshops.

CAL's **Colorado Library Instruction Interest Group** held its August Brown Bag at the University of Denver's Penrose Library. The meeting began with lunch and a meet and greet with librarians from around the state. A tour of the Penrose Library highlighted its rare book collection and the Research Center. **CLiC (Colorado Library Consortium)** offers a variety of workshops throughout the year and across the state. The dates for the Spring Workshops are March 1-2, 2010 in Grand Junction, April 8, 2010 in Fort Collins, and April 15-16, 2010 in Pueblo. <u>http://www.clicweb.org/</u>.

Thomas has worked at OCLC, Unisys, CARL Corporation, The Library Corporation (TLC), and Medialab Solutions. He holds an MLS from the University of Pittsburgh and a BA from Oberlin College. The Marmot Library Network consists of 20 member library systems with 90 buildings scattered over 60,000 geographically challenging square miles in Western Colorado. The Network manages a Millennium integrated library system and provides online library services to approximately 300,000 library users. Marmot supports 1,000 staff and public access workstations as well as network equipment as the Internet service provider for most member libraries.

KANSAS

The **State Library of Kansas h**as posted the first Online Learning Round-up, produced by the State Library's Continuing Education staff, **Shannon Roy** and **Cindi Hickey**, with the latest information about online webinars on a variety of library related topics. (This idea was initiated by **Jamie Markus** of the Wyoming State Library). URLs and registration information for all of these webinars is available at <u>http://statelibrary.mykansaslibrary.org/</u>.

Kansas Talking Books began its widespread delivery of digital Talking Book machines to Kansas veterans and centenarians on September 11. From Great Bend to Chetopa, from Garden City to Harper, nearly 200 users were simply delighted. "This is the difference between a model T and a new Lincoln," commented one user. "It's out of this world – a big improvement." Title selection for the new digital cartridges is somewhat limited for now, but Richard Coleman of Hutchinson noted that it's hard to listen to the cassette machine now that he has the digital machine — the difference between the two is like night and day.

Fifteen librarians from three regional systems in Kansas attended the Association for Rural and Small Libraries Conference in Gatlinburg, Tennessee, September 9-14. Attendees learned how small libraries can achieve staff training goals in 15-minute increments without leaving the library, and what free internet products enable even the smallest libraries to hold online meetings. The Director of *Library Journal's* "Best Small Library" in America described her community's economic, literacy, and employment situation. Next year's ARSL conference will be in Denver, October 14-16, 2010.

The newly-established Kansas statewide courier service, **Kansas Library Express**, experienced a usage increase of 40% from 32,737 in July to 45,745 in August. That resulted in an overall unit cost of .79 per item shipped in August. A significant increase in vol-



ume is expected in October and November, typically the high volume interlibrary loan period in the Fall school semester. Kansas Library Express now serves a total

of 223 libraries, including a number of school libraries that began participation in September.

The State Library of Kansas and the Kansas Center for the Book are again presenting a statewide reading program that brings communities together through reading. Coming next spring is 2010 Kansas Reads...Dreams from My Father: A Story of Race and Inheritance by Barack Obama. This book was first published in 1995, after Obama was elected the first African-American president of the Harvard Law Review, but before his political career began. It was chosen because it addresses issues faced by Kansans across the state. These include memoir writing, the search for an individual's identity, relationships with fathers, and issues of blended families.

ALA's Every *Child Ready to Read* campaign inspired a new *6 by 6 Early Literacy Space*, launched in September at the Antioch Neighborhood Library of the Johnson County Library. The name reflects ECRTR's "Six Skills by Age Six" slogan. Kansas City artist Brad Sneed created six graphics *pro bono* for 6 by 6 flash card sets depicting the six principles of reading readiness, for parents' use, and the same graphics are on the accompanying Web page at <u>www.</u> jocolibrary.org. The Space features specially-designed spaces and furnishings, along with programming. In addition, library staff in all 13 facilities is integrating the 6 by 6 principles into storytimes and following the same model.



The **Topeka & Shawnee County Public Library** and **NEKLS** hosted Celebrate the Book! A regional Reader's Advisory Conference in November. Keynote speaker was Michael Gannon, Booklist review and author of *Blood*, *Bedlam*, *Bullets and Badguys: A Reader's Guide to Adventure/Suspense Fiction*.

The 2008 Johnson County Library Annual Report has won an Award of Excellence from the City-County Communications and Marketing Association (3CMA) in its population category (124,000-3,900,000) and was the only county publication among the winners. Judges' comments: *"Terrific piece of collateral that demonstrates the many offerings and uses of the Johnson County Library. Publication demonstrates the library's relevance to the community."*

MONTANA

The **Montana State Library** announced that the Gale statewide periodical databases have been renewed for the next two years, at no cost to libraries. The State Library is able to pay the cost of this renewal with support of the Governor's budget office and the 2009 Legislature, and the efforts of the State Librarian, the Library Commission, the Montana Library Association and Montana librarians. In addition, Gale's Small Business Resource Center has been added to the statewide suite for one year. The existing EBSCO statewide databases have also been renewed through August, 2010. New to the EBSCO suite this year is "Career Library".

The **Montana Festival of the Book** was held October 22 – 24 in Missoula. This annual festival is sponsored in part by the National Endowment for the Humanities and the National Endowment for the Arts, in association with the Montana Arts Council and Humanities Montana.

The Montana Legislator READ poster series won in the category Innovative Advocacy at a recent National Conference of State Legislatures (NCSL). Photos of legislators were taken during a reception sponsored by the State Library and superimposed on READ posters with "I support Montana Libraries" written on them.

The Big Read under the Big Sky is a month-long event at the Lewis and Clark Library in Helena, featuring *The Things They Carried* by Tim O'Brien. The Library hosts a series of lectures, documentary viewings, book discussion groups, and programs based on the themes presented in O'Brien's work.

Lewis & Clark Library plans to expand its East Helena branch, presently part of the East Valley Middle School library. The branch has outgrown the present space, and will move to a vacant building which will be renovated by the owner and leased back to the library.

The annual **Academic & Special Libraries/Public Libraries** retreat took place October 25-26 at Chico Hot Springs. Topics include genealogy research, medical resources online, hosting a movie night at the library, digitizing your collection and serving the mentally ill.



The **Children's Festival of the Book** was held in Bozeman September 25. Artist Chris Raschka, poet Paul Janeczko, and authors Dorothy Hinshaw Patent, Ben Mikaelson and Sneed Collard were some of the featured speakers.

Jim Peters, Assistant Director of Billings-Parmly Library has retired after a long career, and DeeAnn Redmond has been promoted to that position.

NEBRASKA

Tracie D. Hall presented *The Ten Social Trends that Change the Way Libraries Can and Should Do Business* at the Eastern and Southeast Library **Systems**' Fall Colloquium in November. She also presented an interactive afternoon workshop.

The **Eastern Library System** received a grant from Dollar General to help support the Book Bags for Kid's program.

John Felton, Nebraska Library Commission has developed an interactive, thematic map of Nebraska Public Libraries: <u>http://www.nlc.state.ne.us/Statis-</u> <u>tics/LibraryMap.html.</u> Data is based on the 2007-09 Nebraska Public Library Statistical Survey.

William Ayers, will speak at the fall program/annual meeting of the Academic Freedom Coalition of Nebraska (AFCON). It was one year ago that he was "uninvited" to speak at the University of Nebraska-Lincoln.

Julie Beno's term as Nebraska's representative to MPLA ended in October. She says," I appreciated the opportunity to represent Nebraska and thank you for all the opportunities from attending conferences to meeting new friends. I will continue to be a strong advocate for MPLA."

This dedicated computer provides students with a direct portal to the Theodore Roosevelt Center website, www.theodorerooseveltcenter.com. The Theodore Roosevelt Center is a project of Dickinson State University and the Theodore Roosevelt Initiative. The kiosks provide a focal point for Theodore Roosevelt enthusiasts to conduct their research.

Ten year old Racquelle Ackre won the **Cando Community Library** Design a Book Bag contest. Her bags will be available at the Cando Library.



OKLAHOMA

Pawhuska's Osage Tribal Museum became Oklahoma's eighth official Literary Landmark on November 17, honoring Osage writer John Joseph Mathews. The Literary Landmark project honors historic or community sites that are tied to a deceased literary figure, or to his or her work. More than 100 sites across the country have received the designation since 1986. November is National American Indian Heritage Month, and the City of Pawhuska has declared the week of November 16-20 as John Joseph Mathews Week. Mathews (1895-1979) is best known for his accounts of Southwestern history and the relations between Indians and whites. He became one of the earliest writers to address the loss of traditional Native American culture, and much of his work reflects an appreciation of the land and its connection to that culture. Born near Pawhuska, of mixed heritage, he grew up among the Osage tribe. America's Literary Landmarks program is a project of the national Association of Library Trustees, Advocates, Friends and Foundations (ALTAFF) and is sponsored in Oklahoma by FOLIO.

Librarians in Norman, Oklahoma were concerned



when a visit by a best-selling author to a local middle school was cancelled after a parent protested the event. Author Ellen Hopkins wrote *Glass*, which chronicles her daughter's addiction to methamphetamine. The **Norman Public Library** has been buying more

books to keep up with the demand of readers in the community.

Almost 200 people, including 120 Oklahoma high school students, attended the 2009 **First Amendment Congress** in Oklahoma City in October. The state's library community has been partnering with Freedom of Information Oklahoma, Inc. to host the annual event for the past eleven years. This year's theme was "Muzzling the Watchdog," and sessions focused on the impact of Internet news, blogs and social media on the traditional role of journalism as a watchdog of government. Highlights included an address by award-winning journalist Marvin Kalb, an online tour of watchdog websites by OSU Government Documents Librarian Barbara Miller, a debate on traditional vs. new media by two high school teams, and information on how to be a smart news consumer in the Information Age.

SOUTH DAKOTA

The 2009/2010 *Prairie Bud & Pasque* state book award program is ready to go for grades K-5 students, teachers and librarians. Sponsored by the **South Dakota Library Association**, the contest features two lists of 15 nominated titles. In a change from previous years, the Prairie Bud list is now designed for students in grades K-2 and Prairie Pasque is for grades 3-5. Voting, done online only, begins after Jan.1 and concludes by March 15.



In early September, representatives from South Dakota, Wyoming, Idaho, and Montana met to discuss the Laura Bush (SWIM) grant program. The Institute of Museum and Library Services grant program will give scholarships to 50 students from the four states to earn a Master's Degree in Library and Information Science from the University of North Texas's distance education program or earn a School Library Media Endorsement from distance programs at Black Hills State University, Montana State University, or the University of Montana. The South Dakota State Library will award at least six MLIS scholarships and four media endorsement scholar-ships on April 30, 2010.

The winners of the free MPLA memberships from South Dakota this year are: Marguerite Cullum, Nicki Yackley-Franken, Sandra Brown, Stacia Mc-Gourty, Paula DeMars, Patty Andersen, Joyce Waddell, Jean Diedtrich, Deedra Holdhusen and Fei Xu. **Mike Mullin**, South Dakota representative, welcomes them to MPLA and encourages them to join the hot tub roundtable in Oklahoma City in 2010.

Colleen Smith, Director of the Huron Public Library, is retiring. Her plans include travel and care of her mother.

The **Hermosa Library** found a way to jazz up its walls and keep track of how many books children read over the summer. Librarian Roberta (Bert) Upton created a vine to cover their walls. Each time a child read a book they got a small green paper leaf with their name on it to put on the vine. At the end of



their program the vine went over halfway around the library. This could easily be done in fall colors and spring flowers as well.

UTAH

The University of Utah J. Willard Mar-

riott Library was rededicated on Monday, October 26 after a reconstruction period of 4 years and a cost of \$80 million. Former First Lady Laura Bush delivered the keynote address at the rededication ceremony about the new role of libraries in the 21st Century. Also in attendance was Utah Governor Gary Herbert and the son of the library's namesake, Bill Marriott. Highlights of the renovated library include more areas of the building open to natural light, adding more electrical outlets and Internet ports, and new furnishings with 20-40 year warranties which include "womb" chairs. The new Knowledge Commons is filled with 350 computer work stations and glassed-in sound-proofed group study rooms. The library also features safety measures designed to withstand a 7.2 magnitude earthquake. Another new feature is an automated book retrieval and storage facility. 1.5 million people visit the library each year. Funding came from the State Legislature, federal funds, and pledges and donations.

Josh Hanagarne, Director of the Rose Park Library, a Branch of the Salt Lake City library system was recently featured in an article in the Salt Lake Tribune holding a sledgehammer in the library stacks. Josh is known as the "World's Strongest Librarian" as he exercises with both the sledgehammer and 70 and 53 pound kettlebells to strengthen his wrists. Josh authors a website: <u>www.worldsstrongestlibrarian.com</u> which chronicles his struggle with Tourette's syndrome and his personal philosophies derived from the self-discipline that allowed him to complete his MLS in a year.

The **Utah Library Association Children Services** and the **Young Adult Round Tables** co-sponsored a workshop at the Ogden Valley Branch, located in Huntsville, Utah on September 11. Almost 100 participants attended several programs. Non-fiction expert and author Kathleen Baxter spoke about nonfiction books for teens and tweens and recent popular titles. Other programs covered the topics of crafts for teens, marketing nonfiction collections, and "60 in a Jiffy."which highlighted 60 program ideas.

The Salt Lake City Public Library and the Weber County Library co-sponsored the 2009 Thinking Ahead Symposium at the Salt Lake City Public Library Sept. 10-12. Headlining the conference was Stephen Abram, immediate Past President of SLA and Vice President of Innovation for SirsiDynix; Helene Blowers, Director of Digital Strategy at Columbus Metropolitan Library and creator of Learning 2.0: 23 Things; Danielle Patrick Milam, Director of Las Vegas-Clark County Library District Development Office and Foundation, and previously Senior Vice President of Programs and Development for the Urban Libraries Council; Sandi Parkes, Assistant Vice President of Continuing Education and Professor in the Master of Public Administration Program at the University of Utah; and Nancy Tessman, retired as Director of the Salt Lake City Public Library in July 2007, Executive Director of the Library Leadership Institute at Snowbird, 1994-2001.

Utah libraries have been featured in several news articles lately. An article published in the *Davis Clip*-

per discussed several topics currently being addressed by the Davis County Library Board of Trustees.



The foremost policy addressed was whether gameplaying will be allowed at the library. Information is being gathered about how other Utah libraries handle game-playing issues. Meeting room rules were also discussed.

WYOMING

The Laramie County Library System

recently unveiled an entirely revamped website to the community, which can be accessed through <u>LCLSonline.org</u> or LaramieCountyLibrary.org. Gerry Teano, the LCLS webmaster, spent months working on the new design since he was hired last year. He conducted a variety of usability studies and incorporated numerous focus groups into his planning process. An ongoing project, the website will continue to feature regular changes and updates . Lori Phillips, MPLA Member and Associate Dean of the University of Wyoming Libraries, joins the BCR Board as an at-large trustee.

The **Teton County Library and Foundation** presented four lectures this fall from the 92Y Cultural Center in New York City. The programs are broadcast exclusively to Teton County Library and cannot be viewed on television or the Web. Speakers include contemporary thinkers from politicos to religious leaders to business pundits. Speakers included Howard Dean, Maria Bartiromo, Paul Krugman, and Rabbi Harold Kushner.

The Sheridan County Library System held a food drive for the Salvation Army in November. During this time patrons could donate nonperishable food items in exchange for having their overdue fines forgiven.



The new Alta Branch Library of the Teton County Library opens December 1, with a with a grand opening celebration is planned for early January 2010. The library circulates books, magazines, audiobooks, DVDs and videotapes for adults and children with access to materials from the main branch in Jackson. Computers with Internet access, word processing and Spanish language capabilities are available to the public.

State Librarian **Lesley Boughton** was honored by the Wyoming Library Association with the Unsung Hero Award for her efforts to provide MP3 players to all members of the Wyoming National Guards' 115th Brigade, currently deployed to bases in Kuwait and Iraq. With their Wyoming library cards this allows them to download books and music from WYLD for free, providing a needed diversion for the soldiers.

Michelle Havenga of the Sheridan County Public Library won the Distinguished Service Award from the Wyoming Library Association.

The Natrona County Public Library in Casper is inviting sports and history fans to experience the remarkable history of baseball's Negro Leagues and the challenges and successes of the players at the library this winter. Pride and Passion: The African-American Baseball Experience, a traveling exhibition for libraries, was organized by the National Baseball Hall of Fame and Museum, Cooperstown, New York, and the American Library Association Public Programs Office, Chicago. The traveling exhibition has been made possible by a major grant from the National Endowment for the Humanities: great ideas brought to life. Several special events will be held in conjunction with the exhibit.

Freedom to Read Foundation

The Freedom to Read Foundation (FTRF) is offering free one-year memberships to students graduating from ALA-accredited MLS and MLIS programs and from school library media programs recognized by the American Association of School Librarians (AASL), an educational unit accredited by the National Council for Accreditation of Teacher Education (NCATE). FTRF fulfills its mission through the disbursement of grants to individuals and groups, primarily for the purpose of aiding them in litigation, and through direct participation in litigation dealing with freedom of speech and of the press. National Information Standards Organization - NISO

The **National Information Standards Organization** (NISO) Voting Members have approved a new work item to develop a Recommended Practice related to the physical delivery of library materials. The Working Group roster is now finalized, and work will begin on November 18. Building on the efforts of three recent projects--Moving Mountains, Rethinking Resource Sharing's Physical Delivery Committee, and the American Library Association's ASCLA ICANS' Physical Delivery Discussion Group-the recommended practice document is proposed to include recommendations for: packaging, shipping codes, labeling, acceptable turn-around time, lost or damaged materials handling, package tracking, ergonomic considerations, statistics, sorting, a set of elements to be used for comparison purposes to determine costs, linking of regional and local library carriers, and international delivery.

Sisters in Crime

Sisters in Crime has made the decision to provide funds to libraries whose book acquisitions budgets have been slashed, Sisters in Crime will award \$1,000 to a library each month in 2010. Details of the library grants program will be posted on the national website.<u>www.sistersincrime.org</u>.

OCLC Americas Regional Council

The OCLC Americas Regional Council will hold its first meeting at ALA Midwinter, January 15, 2010, in Boston. The Americas Regional Council meeting will provide an open forum to discuss issues of importance to its members and to advise OCLC about its products, services, policies and operating direction. The Americas Regional Council Executive Committee, members of OCLC Board of Trustees, Global Council and OCLC Management will be present for interactive discussions. Comprised of members from libraries and other cultural heritage organizations from Canada, Latin America and the Caribbean and the United States, The Americas Regional Council is part of the OCLC cooperative's new governance structure that consists of three Regional Councils and a Global Council to facilitate member-to-member discussions across the cooperative.
