

Scottsdale Public Library
Launches READ Local - Arizona
Author Collection. The "Eat Local"
movement encourages people to buy
and eat food that is harvested within
the community. This movement gives
consumers an opportunity to discover
unique community bounty and reestablishes the connection between
the eater and the grower. In the spirit
of the Eat Local movement, the Scottsdale Public
Library is piloting a new READ Local - Arizona
Author Collection in order to:

- -Showcase the emerging literary efforts of the Arizona community
- -Introduce readers to unique homegrown talent that is not yet nationally known
- -Give local authors a tangible way to connect with Arizona readers.
- -Enable the library to further vision and plan for new acquisition models in light of the ongoing changes to the publishing industry.

According to Dana Braccia, Collection Development Coordinator for the Scottsdale Public Library, "we have an amazing wealth of talented authors in our community and many of them have decided to bypass the traditional publishing route. However, because of limited distribution and grassroots marketing efforts, oftentimes readers can only find these unique books online or at special book festivals. We want to make them readily available to the public and celebrate our community creations. I've often heard authors say they knew they'd made it when their books were in the library. We're putting out the welcome mat for our Arizona authors." The collection will be available to the public in the spring of 2010 and will feature adult, teen and youth fiction and nonfiction materials. Dr. Jana Bradley, University of Arizona School of Library Resources and Information Science professor and former director, has been awarded the 2009 Library Leadership Award as well as the President's 2009 AzLA Conference Program Award by the Arizona Library Association.

Arizona State Library, Archives and Public Records Presents Lunchtime Family History Lessons. The topic for the January program was *The Civil War and Genealogy* with information provided on resources

about Civil War ancestry.

Through the Recovery Act Public Computer Center grant, the Arizona State Library Archives and Public Records will help 84 public libraries in the state enhance service to their communities with additional public-access computers in their institutions. Located in areas where citizens have very limited access to computers or the Internet, the expanded capacity at these libraries will provide residents with access to a wide range of online resources, including government, business, and health information, while also facilitating training for job searches and skill development. The libraries will partner with a variety of government, not-for-profit, and tribal organizations in serving residents. It is anticipated that the computer centers will serve more than 75,000 users per week and more than 450,000 residents in total.



EBSCO is providing online training just for Arizona libraries. Each month, two webinars will focus on various EBSCO databases and support resources. This month the sessions will cover resources for Public Libraries and Teachers.

The **Books for Arizona Libraries** (BAZL) program provides funding for Arizona's smaller libraries and literacy groups to acquire quality books from large library systems' book sales. Grant funds are allocated separately to each participating large library system. Friends organizations, literacy groups and public libraries of all kinds are all eligible to shop anytime. NEVADA

Carson City, Nevada voted 4-1 to move forward on the plans for the Nugget Economic Development Project which includes a new state-of-the-art **Carson City Library** located downtown in the 8 acre area surrounding the Carson City Nugget Hotel & Casino. The library is planned to be built with a business and technology incubator and next to a "digital" lab all designed to support business and get Carson City back to work.

Henderson Libraries is now extending its services to the cell phone world with Text a Librarian. The Text a Librarian program allows patrons to send a text message to the library at 66746 to ask questions. For example, send a text to 66746 that begins with askmylib, followed by the question, what are your hours? Within a few minutes, the patron will receive a text message with the answer. Henderson Libraries also now offers a free online service to its patrons allowing anyone to learn a new language. From more commonly spoken languages like Spanish, French and Portuguese to languages rarely heard in the United States like Afrikaans, Greek and Swahili, there is something of interest for everyone. The program, which is part of the libraries' massive Adult Resources section, offers more than 70 languages and gives the user both audio and visual guidance in learning their language of choice. Users must have a Henderson Library card and can sign in online.

The Las Vegas-Clark County Library District announced checkouts of library materials during Fiscal Year 2008-2009 totaled 13.2 million items. This is the third consecutive year in which the library district has broken circulation records. The FY 2008-2009 achievement is a 9% increase over the FY2007-2008 circulation of 12.1 million items. The 9th Annual Visual Poetry Contest was held October 19-November 30, 2009. This juried photographic competition was created to encourage local middle and high school students to showcase their creativity in the visual arts.

A member of the world-famous U.S. Air Force Thunderbirds Demonstration Team was at the **North Las Vegas Library** in November visiting with enthusiasts and presenting a flight demonstration video, stories and information about the Thunderbirds.

Washoe County Library System wrapped up its Fall Reading Program in December. Since the traditional Summer Reading Programs have become so popular, and year-round schools have become so prevalent, the Washoe County Libraries have expanded these events. The libraries continues with its Winter/Spring Reading Program, "Be Cool @ Your Library."



New E-Readers allow the **May-Port CG School** to go "Paperless." Recently, the May-Port CG school library purchased three Kindles from Amazon. According to librarian, **Doreen Rosevold**, the kindles have been a big hit and students really like them. Not



only are students interested in the Kindles, but also other staff members. The Kindles have helped students who benefit from a larger print for reading or need to use the voice function to help follow along with the text. In addition to purchasing Kindles, the library purchased four IPODs loaded with classical music, audiobooks, and podcasts. Students and staff may use the Kindles and IPODs while in the library.

The **Underwood Public Library** now offers wireless Internet service for the public. Now visitors and community members alike can use the library's wireless service with their own laptop and access the Internet without waiting for a public access computer to become available. The "open" wireless Internet service also benefits the city offices which share the same building. Now, people who need Internet access during meetings can access the library's wireless

service without needing to be connected to the city government secured connection.

SOUTH DAKOTA

Mike Mullin, MPLA South Dakota representative, reports that the SDLA Executive Board is in the process of trying to decide what to do with funds that have been raised to provide an endow-

ment for scholarships. Over the last two decades the association has set aside \$50,000 with the intent that the interest from the money would be used to fund continuing education for members in the form of grants to attend training programs or other educational programs. There has been some confusion in past years because the money is comingled with other association funds. A committee was formed last year to recommend what should be done to ensure that the funds would continue to be used for their intended purpose. The committee recommended that the money be used to create a fund within the South Dakota Community Foundation that would pay the interest to SDLA to be used for scholarships. The SDLA Executive Board met with a representative of SDCF at their January 14, 2010 meeting and plans to discuss the idea at their next meeting.

UTAH

Twelve years after serving as Council Member and Mayor of Parowan, Utah, MPLA member Steve Decker is returning to local politics. Steve has again been elected to the Parowan City Council. Since deciding not to re-run for office after his last four-year stint, Steve has become the Director of the Cedar City Public Library, obtained an MLS degree from Emporia State University, and served in various offices in the Utah Library Association including Public Section Chair, Vice President, President, and currently Past President. Steve has also served on MPLA's Awards Committee. He took office on January 4.

The Bill & Melinda Gates Foundation will help Utah, as well as other states, to obtain broadband internet connections. **Utah State Librarian Donna Morris** pointed out that many libraries have currently have inadequate internet speeds.

The *Deseret News* reported about the **Eagle Mountain** library's space problems January 4. Librarian Michele Graves worked in a tiny library 12 feet square room in the back of the fire station which could only accommodate 3-4 patrons. The library then moved to a 640 square foot trailer in 2002 and is now located in a 2,000 square feet area portion of City

Hall. The library now has over 3,000 patrons, almost 10,000 print materials and four computers. Since that time, they have added a little more room, and are lobbying for a larger site.

MPLA member **Britton Lund** has been selected to fill the position of **Washington County Library** Director in St. George. Britton has a Master of Library Science degree from Emporia State University in Emporia, KS., and a Master of Public Administration degree from the University of Utah and recently served as an Assistant Library Director at the Salt Lake City Public Library.

The November 15th issue of *Library Journal* lists several Utah libraries as "Star Libraries". The **Salt Lake City Public Library** appears as the second library on the list of libraries with expenditures above \$10,000,000. The **Mt. Pleasant Library** is listed as a three star library in the \$100,000-\$199,999 expenditure list. The **Milford Public Library** is listed as a five star 5 library in the \$50,000-\$99,999 expenditure range and the **Lewiston Public Library** is listed as a five star library in the lowest range.

The **Utah Library Association** 2010 Conference will take place May 12-14, 2010 at the Dixie Center in St. George, Utah. The theme is "Come together... for Utah Libraries." The keynote speaker will be ALA president and MPLA member **Camila Alire**, who will also be presenting a pre-conference workshop about bilingual services. The film "Hollywood Librarian", which was shown at ALA a few years ago will be shown as part of this year's Presidents' Reception.




WYOMING



honoring African American authors of outstanding books for children and young adults

The American Library Association announced the list of award-winning books at the 2010 Mid-Winter Conference in Boston.

Vaunda Nelson is the author of numer-

ous fiction and nonfiction books for children. In addition to writing books, she has also been a teacher, newspaper reporter, bookseller and is now Youth Services Librarian at Rio Rancho's Esther Bone Memorial Library in New Mexico.

Bad News for Outlaws: The Remarkable Life of Bass Reeves, Deputy U.S. Marshal published by Carolrhoda Books, a division of Lerner Publishing Group, Inc. is a biography of a legendary peace officer. Born into slavery in 1838, Bass had a hard life and a strong sense of right and wrong. Bass was one of the most feared and respected lawman in Indian Territory. During his career, he made more than 3,000 arrests but killed only fourteen men.

"The winning title for text was selected because it is engaging, meticulously researched, and offers a riveting account of an unsung African American hero," said Carole McCollough, Award Jury Chair.

The Coretta Scott King Book Awards annually recognizes outstanding books for young adults and children by African-American authors and illustrators that reflect the African-American experience.

Maureen Sullivan, MPLA's Leadership Institute Facilitator, is named ACRL 2010 Academic/ Research Librarian Of The Year. The award, sponsored by YBP Library Services, recognizes an outstanding member of the library profession who has made a significant national or international contribution to academic/research librarianship and library development.

She will receive a \$5,000 award at June 26, at the joint ACRL/LLAMA Awards Presentation at the 2010 ALA Annual Conference in Washington, D.C.

"Maureen's career has been deeply influential across the spectrum," said Barbara Jenkins, chair of

the ACRL Academic/ Research Librarian of the Year Award Committee and Director for Instruction and Campus Partnerships at the University of Oregon. "Her work in organizational development and strategic planning has had a unique and lasting impact on many individuals and organizations. Almost



single handedly, she ushered academic libraries into the world of effective strategic planning - strategic planning that has had a significant impact on how we engage our students, faculty and others who use our libraries. She has been a model for others in how to reach out, mentor and engage new professionals and experienced collages."

"I am honored to receive this award," said Sullivan. "It is especially meaningful because of all of the opportunities that ACRL and its members have given me throughout my career. I am very fortunate to have received support and guidance from so many colleagues in ACRL and in the profession."

Operation Teen Book Drop

Readergirlz was launched in March 2007 in celebration of Women's National History Month. This community of young adult authors and teen readers is the top online group for teen girls' literacy. Founded by five women authors in the Seattle area, readergirlz works to produce online monthly issues published through www.readergirlz.com. Readergirlz features a young adult novel and accompanying service project each month via this publication. The authors also contribute to a blog (readergirlz.blogspot.com) and support two special literacy projects a year. This online community has already been recognized for the work they have done to promote teen literacy and leadership in girls, receiving a James Patterson PageTurner award in 2007. In November 2009, readergirlz received an Innovation in Reading Prize from the National Book Foundation.

Operation Teen Book Drop is the result of a partnership between readergirlz, Young Adult Library Services Association (YALSA), and GuysLit Wire. Operation Teen Book Drop is a nationally coordinated effort to get new books to teens in need. In 2008 and 2009 Readergirlz delivered over 20,000 books to teens in hospitals to help celebrate Support Teen Literature Day. This year's book drop will take place on April 15, 2010 and will contribute books to 10,000 teens attending tribal schools.

Operation Teen Book Drop has paired with If I Can Read, I Can Do Anything which is a national reading club for Native students. Operation Teen Book Drop has been working with tribal librarians across the country to coordinate the distribution of books. Currently, 36 schools with over 7,800 students are participating in the program. Over half of these schools are located in states included in the Mountain Plains Library Association. The 17 schools in the region are located in Nebraska, Wyoming, New Mexico, Oklahoma, South Dakota, and Arizona and have over 4,500 students enrolled in the program. The schools include:



Alchesay High School, Arizona Andes Central School, South Dakota Canyon Day Junior High School, Arizona Crow Creek High School, South Dakota Eufaula Dormitory, Oklahoma Greyhills Academic High School, Arizona Leupp Schools, Arizona Monument Valley High School, Arizona Ojo Encino Day School, New Mexico Riverside Indian High School, Oklahoma Rock Point Community School, Arizona Pyramid Lake Junior/Senior High, Nevada Santa Clara Day School, New Mexico Santa Fe Indian School, New Mexico St. Peters Indian Mission School, Arizona St. Stephens Indian High School, Wyoming Walthill Public School, Nebraska
