

# Great people with great ideas have led to an AMAZING organization!

MPLA had a modest beginning when the idea for a regional association grew out of the cooperative efforts started by the Bibliographical Center for Research (BCR) with a \$30,000 Carnegie grant in 1935. On Sunday, August 29, 1948, Mr. Esterquest gaveled the first general session to order at 3:00 p.m. in the West Room of the Manor House of the Stanley Hotel, Estes Park, Colorado. The delegates unanimously elected him as presiding officer. After reviewing the developments that led to calling the conference, he introduced the Planning Committee which included:

- Mrs. Ruth V. Tyler, Midvale, UT
- Miss Laura Makepeace, Fort Collins, CO

Papers were presented on "Why have library associations" and Mrs. Tyler moved that "This conference resolve itself into a regional association and that the chairman appoint a Committee on Constitution and By-Laws and such other committees as he might see fit." The Tyler motion was voted and carried. The Mountain-Plains Library Association was born! And the meeting adjourned at 6:00 p.m. The delivery took three hours. By dinner time, the Planning Committee had appointed Constitution and By-Laws and Nominating committees with a charge to complete their work by the Tuesday general session. A lot can happen by dinner time!

As your MPLA President this past term, I have had the privilege to experience this tradition of innovation and action first hand. This has been a dynamic year for libraries and MPLA has been at the forefront of offering key networking and educational opportunities to help our members to successfully navigate new challenges and patron expectations.

Thanks to all of the great people with great ideas who have helped to make this a truly AMAZING year!



## MPLA Literary Contribution Award

## Hugh Reilly, Bound to Have Blood

From the nomination: Hugh Reilly's book *Bound to Have Blood* examines the newspaper coverage of several key events in the Plains Indian Wars. This work of non-fiction analyzes the reporting of the period and how news depictions of Native Americans reinforced negative stereotypes... The concept of this book is unique. Using research from many different sources, the author compares and contrasts the atmosphere of the time with the reporting of the incidents.... In addition to reviewing newspaper accounts, this academic work also details military actions leading up to the conflicts, as well as the

state and national political climate before and after the events. The Plains Indian Wars occurred in states and territories of the Mountain Plains region, and this book is an attempt to create a better understanding of the events of the time. It is an entertaining read, yet it is also a scholarly work derived from a great amount of research. Hugh Reilly, is an associate professor in the School of Communication at the University of Nebraska at Omaha. He is a member of the university's Native American studies faculty. He is also the coauthor of "Historic Omaha: An Illustrated History of Omaha and Douglas County" and "Father Flanagan of Boys Town: A Man of Vision".

## Kathy Barco, READiscover New Mexico: A Tri-Lingual Adventure in Literacy

From the nomination: *READiscover New Mexico: A Tri-Lingual Adventure in Literacy* by Kathy Barco has furthered the understanding and appreciation of New Mexico by introducing New Mexico's culture, history, and literature to thousands of children of all ages. *READiscover New Mexico* is an astute workbook and guidebook created to assist teachers, librarians, and parents as they teach children ages 5 to 18 about New Mexico. The book encourages children and adults alike to discover the vast cultural, natural, historical, and literary treasures found in New Mexico. The book is especially

important this year during New Mexico's 2012 100th statehood anniversary. Kathy Barco has worked in libraries for 21 years and is currently the Literacy Coordinator for the Albuquerque/Bernalillo County Library System. Her other publications include: *True Stories of Censorship Battles in America's Libraries* (ALA, 2012), *Breakfast New Mexico Style* (Sunstone, 2009), and *Breakfast Santa Fe Style* (Sunstone, 2006). Barco is vice-chair of the New Mexico Library Foundation and won the Leadership Award from the New Mexico Library Association in 2006. She has collaborated with New Mexico scientist/photographer, Relf Price, by writing haikus to accompany his photographs in the annually published calendar, "Jewels of the New Mexico Skies." She is currently writing haikus to be published in Price's book Valles Caldera National Preserve – Land of Entrancement (forthcoming 2013, LPD Press).

## Jean Lukesh, The Nebraska Adventure

From the nomination: Jean is the author of *The Nebraska Adventure*, first published in 2004. It is a textbook on Nebraska history and is currently used by approximately 85% of elementary schools across the state. *The Nebraska Adventure* won the 2005 national Texty Award for textbook excellence in the Humanities and Social Sciences at the Elementary-High School level, the 2006 Nebraska Book Award for Children's Nonfiction, and a 2006 Moonshell Arts and Humanities Council

Literary Award. Jean also co-wrote a local sesquicentennial history book of Hall County, Nebraska, which won a Moonshell Literary Award in 2008. As an author, editor, and historian, she is still often invited to give book, history, or writing presentations in classrooms and at conferences all across the state. The Nebraska Regional Library Systems have had Jean present workshops at regular intervals over the years and she has always proven to be a popular speaker. Over the past year or so, Jean has worked with MONA (the Museum of Nebraska Art) in Kearney doing history research and presentations for their Collection Connection. She worked, too, with University of Nebraska at Kearney, the Archway Monument, and Kearney Public Schools as an educational consultant for their summer school PAWS project on the Pawnee Indians, one of her favorite subjects. She was also a consultant for them when the Pawnee came from Oklahoma to do a powwow at the Archway Monument. Jean is working with fellow Nebraska author Roger Welsch on the repatriation and restoration of the Pawnee to Nebraska and recently received a certificate of appreciation from the Pawnee.

## Robert Day, The Last Cattle Drive

From the nomination: While Robert Day has written many short stories published in collections such as, "In My Stead", "The Four Wheel Drive Quartet", and "Speaking French in Kansas", he is primarily known for his classic work, *The Last Cattle Drive* which takes place in and around Hays, Kansas. A reviewer says "Bob Day's novel is like the man himself--ebullient, precise Rabelaisian, witty. It's written in remarkably fine North American English. It wears its cowboy boots, as does the author himself, very comfortably and with a highly polished panache." Another says "Tightly written and powerfully evocative. The smells, sights and sounds of Kansas are described so well at times that one begins to cough as the dust crawls up through the floorboards of the battered pickup." His never ending love of Kansas shows in his writing, and also in his character. I've had him speak several times at my library and he is always a hit, always finding the perfect words to describe the land and people of the Midwest. Robert Day was also one of the founders of the Cottonwood Review, a literary arts journal still published at the University of Kansas.

Robert Laxalt, Sweet Promised Land (1957); In a Hundred Graves (1972); Nevada: A History (1977); A Cup of Tea in Pamplona (1985); The Basque Hotel (1989); Child of the Holy Ghost (1992); and The Governor's Mansion (1994)

From the nomination: Robert Laxalt (1923 -2001), the son of Basque immigrants, referred to the Nevada State Library in Carson City as his second home during his childhood. He studied Basque culture in France and Spain as a Fulbright scholar. In his early career as a journalist, he wrote for the *Nevada Appeal*, *Nevada State Journal*, United Press International, the *Wall Street Journal*, the *New York Times*, and launched the Capital News Service in 1947. He was the voice of the Basque immi-

grants in America. In 1954, Laxalt joined the staff of the University of Nevada, Reno, as the director of News and Publications. He helped found and direct the University of Nevada Press and was Writer-in-Residence at the university. He was also a co-founder of the Center for Basque Studies at the University of Nevada, Reno. In 1986, he was awarded the Tambor de Oro from the City of San Sebastian for his contributions to the Basque people and their country. In 1988, Laxalt became the first person named to the Distinguished Nevada Author Chair at the university. At his retirement, he was designated Director Emeritus of the University of Nevada Press. In 1998, Texas Christian University included Laxalt in their *Literary Chronology of the American Wes*t (1510-1984).

## MPLA Distinguished Service Award

Scott Zollars, Director of Library Services, Labette Community College Parsons, Kansas.

From the nomination: Each year, Scott attends a variety of conferences and meetings so he can keep abreast of technology and services to best serve our students... Each year Scotty budgets for a Paper of the Year award for our students. There are monetary prizes, plaques and certificates, and the first place winners are placed in the library's collection. This is great way to support the colleges writing across the curriculum initiative. .. Each semester, Scotty provides information to new faculty along with a tour to get them comfortable coming to the library. Faculty are encouraged to bring

classes to the library so students can learn how to find information quickly and easily. Online students are also an important consideration for Scotty, and a great deal of effort is given to ensure electronic resources are available as well. Scotty and his library staff provide everything from interesting displays to silly treats to entice everyone at the college to stop in just to visit the library. Things like this pay off in getting everyone to know the library staff and use the library more.... Scotty deserves to be recognized not for one specific act or accomplishment, but rather for doing the right thing consistently over a 12 year period to make our library the best it can be for our students, faculty, employees and community members. Scotty attended the MPLA 2012 Leadership Institute.

## Irving Nelson, Librarian, Navajo Nation, Window Rock, Arizona

From the nomination: Irving Nelson is an extraordinarily dedicated librarian that routinely does things that are far beyond the call of duty. Our literacy organization, Reader to Reader, collects roughly 10,000-15,000 books every 6 months for the Navajo Library, its branch library in Kayenta, and for schools and community centers on the Navajo nation. Mr. Nelson flies to Massachusetts, rents a 36-foot truck, and drives for 4½ days back to Window Rock, Arizona. He has done this already three times since 2009, and he will be making his fourth trip in July of 2012. He is planning another trip in November 2012. His willingness to take on this grueling task is just one aspect of this remark-

another trip in November 2012. His willingness to take on this grueling task is just one aspect of this remarkable person. We have seen firsthand the care he puts into improving and maintaining the library's collection, and it is an honor to work with him.



**Mary Stansbury**, Domain Chair, Library and Information Science Program, University of Denver, Denver, Colorado

From the nomination: In 2011, Dr. Stansbury led the successful re-accreditation of DU LIS Program. Under Dr. Stansbury's leadership, the DU LIS Program not only meets but exceeds the highest standards set for the field. This is a significant long-term contribution that ensures that an LIS Program of the highest caliber continues to educate new library and information professionals in the Mountain Plains region. As the Principal Investigator for the IMLS Early Childhood

Librarianship (ECL) Fellowship, Dr. Stansbury was able to secure funding for tuition and stipends for ten fellows for 2010-2012. The students will be prepared to serve the early literacy needs of very young children (0-5 years), caregivers, families, educators, and community coalitions in Colorado. Dr. Stansbury is also an Associate Professor in the LIS Program, exposing her students to ideas, resources and viewpoints that enrich their academic studies.

**Christopher Rippel**, Continuing Education Consultant, Central Kansas Library System, Great Bend, Kansas

From the nomination: Chris Rippel has continually been an outspoken advocate for both libraries and patrons in rural areas of the United States, especially here in Kansas. He is not afraid to acknowledge that sometimes the needs of rural patrons do not coincide with those in urban areas... His interest in new technology has enabled Chris to raise the awareness of librarians about ebooks and ereaders for years; he was lecturing about the Rocket eBook when it first came out around 1998 and continues to train librarians and patrons in both the use of ereaders and the various options for libraries' use of ebooks.... Chris has presented sessions at venues around the United States on several topics, ranging from gaming in libraries to ereading/ereaders to marketing the library.

## MPLA Beginning Professional Award

**Danielle De Jager-Loftus,** Fine Arts/Technology Librarian, University of South Dakota, Vermillion, South Dakota

From the nomination: Danielle is recognized as a leader in using technology for teaching, reference and research services, and outreach. Danielle has led the University Libraries in initiatives to adopt CONTENTdm, LibGuides and LibAnswers, and Smart Board technology among other technologies.... While there are a number of initiatives led by Professor Loftus to which one can point, perhaps most poignant is her collaboration with the USD Director of the Center for Disabilities on the control of the Center for Disabilities on

advocating for and educating about Universal Design and Adaptive Technologies in libraries. Danielle is recognized as a leader for taking the steps to ensure that the library is more technology-enabled for exceptional students and others. Her work in this area is characteristic of accomplishing tasks that serve others through collaboration... Professor Loftus has made a significant impact on library services through her use of technology, her vision for partnering with other campus departments to better serve faculty and students, and her service to the profession and region. Danielle attended the MPLA 2012 Leadership Institute.

**Rebecca Lubas**, Director of Cataloging & Discovery Services, Assistant Professor University of New Mexico Libraries, Albuquerque, New Mexico

From the nomination: Since arriving at the University of New Mexico, Professor Lubas has implemented several discovery tools to enhance access to our catalog data. She has revived our participation in BIBCO and NACO. She has trained many of the catalogers in non-MARC metadata and they now actively contribute to our digital collections. In 2011 Professor Lubas published *Practical Strategies for Cataloging Departments* with Libraries Unlimited. The book has been well-received,

and she has done an ALCTS ALA program on themes from the book, an OCLC Webjunction seminar, and will be conducting a preconference workshop on "Boot Camp for Cataloging Managers" at the OLAC Conference this fall. Beyond her state and national activities, Professor Lubas participates in international outreach. In 2006 and 2012 she traveled to Kosovo to conduct cataloging training with librarians at the National and University Library in Pristina, Kosovo. Her work includes providing skill training to librarians in an emerging democracy, helping them to preserve and present their cultural heritage within and beyond their borders. Rebecca attended the MPLA 2012 Leadership Institute.



## Robin Clark, Director, Sump Memorial Library, Papillion, Nebraska



From the nomination: Robin has implemented many positive changes (but not always popular, which makes her a great director,) while she has been the director. She has an understanding about what it takes to get a problem solved and is a great role model to her staff when solving patron and staff issues. She is a leader within the community and is Lions member besides her numerous other responsibilities. Jason Walker, Library Supervisor, Rapid City Library, South Dakota.



Knowledge Network Facebook, and the 1972 Flood pages and wiki. After the RCPL collection reached 5000+ items, Jason started Library Thing listing RCPL owned books. Jason has expanded the exposure and depth of Library Thing through widgets on the RCPL Facebook page and its inclusion in the Research and Databases link on the RCPL homepage.... He continues to demonstrate exuberance and dedication to his position and is distinguishing himself through his positive impact on the quality and skill of staff and the progressive technological services offered to patrons.





## **IMLS Announces Grant to Identify Library E-Book Strategies**

The Institute of Museum and Library Services (IMLS) announced a \$99,957 grant to OCLC for "The Big Shift: Advancing Public Library Participation in Our Digital Future." The purpose of the grant is to more fully understand the challenges that U.S. public libraries face in providing e-book content to borrowers.

The number of public libraries that offer e-books has doubled in the past five years—to 76 percent from 38 percent, according to a new American Library Association report. Thirty-nine percent of libraries also offer e-readers for check-out to their patrons.

A new study released by the <u>Pew Research Center's Internet and American Life Project</u> identifies opportunities and challenges faced by public libraries for this growing line of service. The report states that 12 percent of people borrowed an e-book from their libraries in 2012. Yet the report documents significant difficulties:

- 56 percent of e-book borrowers from libraries said that at one point or another they had tried to borrow a particular book and found that the library did not carry it.
- 52 percent of e-book borrowers said that at one point or another they discovered there was a waiting list to borrow the book.
- 18 percent of e-book borrowers said that at one point or another they found that an e-book they were interested in was not compatible with the e-reading device they were using.

The study also reports a wide range of library concerns with the cost and availability of titles often related to terms set by publishers.

The purpose of the IMLS award is to ensure that all Americans continue to have access to commercially produced content through their local public libraries even as formats change.



## COLORADO

The **Loveland Public Library** held a "Let's Talk Beer," program with Ed Sealover, author of *Mountain Brew: A Guide to Colorado Breweries*, in September for those 21 years old or older. After the program



Each group created 3 presentations: an oral presentation for a funding authority; screenshots for projects; and a 3-to-5 minute video that featured all group

The **Oakdale Library** Board changed the library's name to **Lois Johnson Memorial Library** to honor Lois Johnson's long-term support and service to the library. She not only purchased the library building

but also renovated the structure before donating the library to the village of Oakdale. A special event was held in July to honor her and celebrate the new library's name.

Les and Jan Hosick opened their home, the Dancing Leaf Earthen Lodge, in Wellfleet for the **Republican Valley Library System**'s 2012 Annual Meeting on June 1. A special lunch featured Native American foods and included buffalo stew with beans, Indian corn (hominy), sunflower seeds, root vegetables, melons, and blue corn muffins with local honey. It was reported to be a fascinating experience to enjoy a meal that was eaten along the Medicine Valley nearly 1,000 years ago.

After months of construction, an Open House was held to celebrate the new **Elwood Public Library** on July 28. After a ribbon-cutting, the crowd heard remarks by the mayor and met architect Daniel P. Drain of Miller & Associates. **Jane Hilton**, Library Director, also announced that open hours would increase from 17 to 23. The library is now closed only on Friday and Sunday.

Frankie Kirkwood, Valley Public Library Director, has retired after leading the library for ten years. She plans to travel, relax, read, or take a class at Metro Community College. Clair Bushong, the new Valley Public Library Director, previously taught organ at Midland University in Fremont.

to Eloise Buhman, her mother-in-law, and worked in the old library. Linda was appointed Library Director in 1995 and is retiring from the new library donated by Ed and Donna Robinson in 2006. She plans to spend more time with her family and travel.

Omaha Public Library's scalp received some recent news coverage. Both the *New York* 

Times (22 June 2012) and the Omaha World-Herald (6 August 2012) have recently written about the library's most grisly relic. An early 20-century account of the scalping was printed in the St. John (New Brunswick, Canada) Daily Sun on 4 August 1903 (http://news.google.com/newspapers?nid=37&dat=19030804&id=aWgxAAAAIBAJ&sjid=aSkDAAAAIBAJ&pg=4051,810111). William Thompson, a Union Pacific worker, was sent from Omaha to fix a telegraph line near Lexington in 1867. He was attacked by a Cheyenne warrior party on August 6, shot in the shoulder, and scalped. After recovering from a faint, he grabbed his scalp and boarded a train for Omaha. When R.C. Moore,

an Omaha doctor, declined to reattach the scalp, Thompson tanned the scalp and returned to England. He spent years showing off the scalp for a fee. In 1900, Thompson sent the scalp back to Dr. Moore because "he was getting old and few people wanted to believe the scalping story." The relic was promptly donated to the Omaha Public Library. It was displayed in a glass bell jar until 1977 and was the highlight of the Main Library tour for many school children.

they viewed original footage of the landing of Curiosity on Mars. The Discover Tech exhibit will travel to Carson City Library in April of 2014.









In late July the South **Dakota Broadband Initiative** announced 15 recipients of over \$112,000 in technology grants. Among the 15 are five public libraries located in Beresford, Phillip, Miller, Madison and Gettysburg. To qualify for the grant, applicants

Anchor Institution and provide a 20 percent matching investment. Projects funded include a variety of infrastructure updates and improvements. In Phillip, the Haakon County Public Library Director and MPLA member Annie Brunskill reports, "Our library is one of the lucky recipients of the SD Broadband Technology Initiative grants in the amount of \$2924.01. We'll be getting one new desktop PC, two laptops, an Internet filtering software bundle, and a switch to help speed up our Internet." Library Director Ray Caffee explains, "The Technology Plan-

ning Grant we have received for the **Hand County Library** in Miller will be used to upgrade aging computers and replace a few computers that are no longer in service. Sadly, we still have a Windows 95 computer! We will be able to add four computer stations for public internet access (added to the



four computers still in operation from our last Gates grant), a computer for our OPAC, a computer for circulation and one for the staff. We will also be able to upgrade some networking equipment. As an anchor institution for our rural area, it is important for us to keep our technology current, and this will give us a big boost in that regard."




